NUNC PRO TUNC ASSIGNMENT

WHEREAS, PRIME ALLIANCE SOLUTIONS, INC., a corporation organized under the laws of the state of Washington, and having its registered agent at National Registered Agents, Inc., 1780 Barnes Boulevard, S.W., Building G, Tumwater, WA 98512-0410 (hereinafter "Assignor") is the owner of the trademarks listed on the attached Schedule A, and the goodwill symbolized thereby ("the Trademarks"); and

WHEREAS, pursuant to the terms of a previously executed General Deed of Assignment of Intellectual Property Rights, and effective as of July 31, 2013 Assignor sold, assigned and transferred all of its right, title, and interest in and to the Trademarks to ACCENTURE GLOBAL SERVICES LIMITED, a corporation organized under the laws of Ireland, located and doing business at 3 Grand Canal Plaza, Upper Grand Canal Street, Dublin 4, Ireland (hereinafter "Assignee"); and

WHEREAS, the parties are desirous of ratifying and confirming said sale, assignment and transfer of all right, title and interest in and to the Trademarks and the goodwill symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned and hereby sells, assigns, transfers and sets over to Assignee, nunc pro tunc as of July 31, 2013, the entire right, title, interest in and to the Trademarks and the goodwill of the business connected with the Trademarks, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.

Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past infringements of the Trademarks assigned.

This Assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
