**4. Restrictions, if any, on share transfers**

The shares of the Corporation shall not be transferred without the consent of either (i) the directors evidenced by a resolution passed or signed by them and recorded in the books of the Corporation or (ii) the holders of not less than 75% in number of the issued and outstanding shares of the Corporation carrying voting rights under all circumstances.
