(b) The Board of Directors of the Corporation, by Unanimous Written Consent of the Board of Directors, adopted a resolution in which was set forth the foregoing Amendment.

(c) The Amendment of the Articles of Incorporation of the Corporation as hereinabove set forth is limited to a change expressly authorized by Section 2-605 of the Maryland General Corporation Law to be made without action by the stockholders of the Corporation.

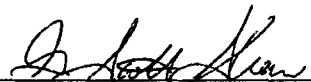
