TERMINATION AND RELEASE OF SECURITY INTEREST  
IN CERTAIN PATENT AND TRADEMARK RIGHTS

TERMINATION AND RELEASE dated as of October 9, 2013, from Square 1 Bank ("Square 1"), which maintains an office at 406 Blackwell Street, Suite 240, Durham, North Carolina 27701, to HighRoads, Inc., a Delaware corporation (the "Grantor"), which maintains an office at 120 Presidential Way, Woburn, Massachusetts.

WITNESSETH:

WHEREAS, pursuant to the terms of a Loan and Security Agreement, dated as of May 18, 2008, as amended from time to time, by and among, among others, the Grantor and Square 1, the Grantor granted a security interest (the "Security Interest") to Square 1 in certain collateral, including the Patents and Trademarks (as hereinafter defined);

WHEREAS, pursuant to the certain Intellectual Property Security Agreement dated as of November 7, 2008, the Grantor reaffirmed its intent to grant a Security Interest to Square 1 in those certain patents ("Patents") and trademarks ("Trademarks") set forth on Exhibit A hereto:

WHEREAS, the Security Interest was recorded with the United States Patent and Trademark Office on the Recordation Dates and at the Reel and Frame Numbers set forth in Exhibit A; and

WHEREAS, Square 1 now desires to terminate and release the entirety of its Security Interest in the Patents and Trademarks, including the goodwill of the businesses with which the Patents and Trademarks are associated;

NOW, THEREFORE, for good and valuable consideration the receipt of which is hereby acknowledged, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Square 1 hereby states as follows:

1. Release of Security Interest: Square 1 hereby terminates, releases and discharges its Security Interest in the Patents and Trademarks, and any right, title or interest of SQUARE 1 in such Patents and Trademarks shall hereby cease and become void.
2. Further Assurances: Square 1 hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
