GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Agreement"), dated December 13, 2013, is made by Mycoskie, LLC, a California limited liability company with its principal office at 4722 Bunny Run, Austin, TX 78746 (the "Grantor"), in favor of BANK OF AMERICA, N.A., as Agent for its own benefit and the benefit of the other Credit Parties, with offices at 100 Federal Street, 9th Floor, Boston, MA 02110 (the "Grantee"). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Grantor and the Grantee are parties to that certain Intellectual Property Security Agreement, dated as of the date hereof, (the "Intellectual Property Security Agreement"), pursuant to which, as security for the payment or performance, as the case may be, in full of the Term Loan Obligations, the Grantor granted to the Agent, its successors and assigns, for its own benefit and the benefit of the Credit Parties, a security interest in all of the Grantor's right, title and interest in, to and under the following property, whether now owned or now due, or in which the Grantor has an interest, or hereafter acquired, arising, or to become due, or in which the Grantor obtains any interest and all products, Proceeds, substitutions, Accessions of or to the Intellectual Property Collateral; and

WHEREAS, pursuant to the Intellectual Property Security Agreement, the Grantor is required to execute and deliver this Agreement to the Grantee.

NOW THEREFORE, in consideration of the mutual conditions and agreements set forth in this Agreement, and for good and valuable consideration, the receipt of which is hereby acknowledged, as security for the payment or performance, as the case may be, in full of the Term Loan Obligations, the Grantor hereby grants to the Agent, its successors and assigns, for its own benefit and the benefit of the Credit Parties, a security interest in all of the Grantor's right, title and interest in, to and under the following property, whether now owned or now due, or in which the Grantor has an interest, or hereafter acquired, arising, or to become due, or in which the Grantor obtains any interest and all products, Proceeds, substitutions, Accessions of or to the following property (collectively, the "Trademark Collateral"): (i) all trademarks, trade names and service marks registered with the United States Patent and Trademark Office and (ii) all United States trademarks, trade names, domain names, trade dress, trade styles, service marks, designs, logos and other similar source identifiers of the Grantor, whether registered or unregistered, including, without limitation, the trademark registrations and trademark applications listed in Schedule A attached hereto (the "Trademarks"), and all written agreements to which the Grantor is a party providing for the grant or license by or to the Grantor of any right under any Trademark ("Trademark Licenses"), together with (i) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect to any of the foregoing, including, without limitation, payments under all Trademark Licenses entered into in connection therewith and damages and payments for past or future infringements, misappropriations or dilutions thereof, (ii) the right to sue for past, present and future infringements, misappropriations, and dilutions of any of the foregoing, and (iii) the Grantor's rights corresponding to any of the foregoing throughout the United States; provided, however, that the Trademark Collateral shall not include, and the security interest granted hereunder shall not attach to, (a) any lease, license, contract or agreement to which the Grantor is a party (including any of its rights or interests thereunder) or property rights of the Grantor of any nature if the grant of a security interest under any Loan Document therein shall constitute or result in (i) the abandonment, invalidation or unenforceability of any right, title or interest of the Grantor under such lease, license, contract, agreement or property right or result in the Grantor's loss of use of any asset, or (ii) a breach or termination pursuant to the terms of such lease, license, contract or agreement, or a default under, any such lease, license, contract, agreement or property right (other than to the extent that any restriction on such assignment or such other term would be rendered ineffective pursuant to Sections 9-406, 9-407, 9-408 or 9-409 of the UCC (or any successor provision or provisions) of any relevant jurisdiction or any other applicable Law

(including any Debtor Relief Law) or principles of equity), (b) any lease, license, contract or agreement to which the Grantor is a party (including any of its rights or interests thereunder) or any property right of any nature to the extent that any applicable Law prohibits the creation of a security interest thereon under any Loan Document (other than to the extent that any restriction on such assignment or such other term would be rendered ineffective pursuant to Sections 9-406, 9-407, 9-408 or 9-409 of the UCC (or any successor provision or provisions) of any relevant jurisdiction or any other applicable Law (including any Debtor Relief Law) or principles of equity); (c) any application for trademarks and service marks filed in the PTO pursuant to 15 U.S.C. § 1051 Section 1(b), unless and until evidence of the use of such trademark or service mark in interstate commerce is submitted to and accepted by the PTO pursuant to 15 U.S.C. § 1051 Section 1(c) or 1(d); (d) any foreign Intellectual Property (which for purposes of this clause (d) shall mean "Intellectual Property" as defined in the Credit Agreement) owned by or licensed to the Grantor; (e) any identifiable proceeds from, and intellectual property rights in respect of, "Start Something That Matters"; (f) any engagement fees or amounts received in connection with speaking engagements or appearances; and (g) any outdoor advertising licensing fees; provided, however, the Proceeds from any asset described in clauses (a) through (d) (except as expressly set forth in clauses (e) through (g)) above shall not constitute "Excluded Assets" to the extent such Proceeds themselves do not constitute an asset described in clauses (a) through (d) (except as expressly set forth in clauses (e) through (g)) above.

This Agreement has been entered into in conjunction with the provisions of the Intellectual Property Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Intellectual Property Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Intellectual Property Security Agreement, the provisions of the Intellectual Property Security Agreement shall govern.

THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.

This Agreement may be executed in counterparts, each of which shall constitute an original but all of which, when taken together, shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or other electronic transmission shall be as effective as delivery of a manually executed counterpart of this Agreement.
