Pursuant to Section 252 of the General Corporation Law of the State of Delaware, the undersigned corporation DOES HEREBY CERTIFY:

1. That the names and states of incorporation of the constituent corporations of the merger are as follow:

Duck Duck Go Acquisition Corp. ("Survivor")	Delaware
Duck Duck Go, Inc. ("Non-Survivor")	Pennsylvania

2. That an Agreement and Plan of Merger between the parties to the merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 252(c) of the General Corporation Law of the State of Delaware.

3. That the corporation surviving the merger shall be Survivor.

4. That the Certificate of Incorporation of Survivor shall continue to be the certificate of incorporation of the surviving corporation, provided that the name of the surviving corporation shall be "Duck Duck Go, Inc."

5. That the executed Agreement and Plan of Merger is on file at the principal place of business of the surviving corporation, the address of which is 190 Country Lane, Phoenixville, Pennsylvania 19460-1703.

6. That a copy of the Agreement and Plan of Merger will be furnished by the surviving corporation, on request and without cost, to any stockholder of any constituent corporation.

7. Non-survivor has 1,000,000 authorized shares of common stock, no par value.
