**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of December 19, 2013, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as collateral agent (the "**Collateral Agent**"), under the Amended and Restated Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Amended and Restated Credit Agreement, dated as of November 29, 2011 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements, patents security agreements and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the "**Credit Agreement**"), among PODS Funding Corp. II (the "**Borrower**"), the other Persons signatory thereto, the Collateral Agent, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrower and certain Persons granted security interests in certain intellectual property owned by Borrower and such Persons including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office on the dates and on the reels and frames set forth on Annex I hereto;

NOW THEREFORE, the Collateral Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements, the Collateral Documents or any other agreement or document delivered in connection with the Credit Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Intellectual Property Collateral to the Borrower and such Persons, respectively.

The Collateral Agent agrees, at the Borrower's expense and such Persons' expense, to cooperate with the Borrower and the Persons and to provide the Borrower and the Persons with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
