THIS ASSIGNMENT is dated 31 of May 2013 and is made

BETWEEN

- (1) **WHALEN FURNITURE MANUFACTURING INC.**, a company incorporated under the laws of the State of California (the “**Assignor**”); and
- (2) **LF CENTENNIAL LIMITED**, a company incorporated under the laws of the British Virgin Islands, with registration no. 1043130 (the “**Assignee**”).

WHEREAS

- (A) The Assignor is the legal and beneficial owner of certain trademarks, utility/utility model patents, design patents and the owner/registrant or applicant of the registrations or applications of such trademarks, utility/utility model patents and design patents as set out in the Schedule (“**Intellectual Property**”).
- (B) The Assignor, the Assignee and other parties entered into an agreement on 21 May 2013 in respect of the sale and purchase of certain assets and business of the Assignor (the “**SPA**”). Pursuant to the SPA, the Assignor agrees to assign the Intellectual Property to the Assignee with effect from the date of this Assignment.

NOW THIS ASSIGNMENT WITNESSES THAT

1. In consideration of the consideration paid by the Assignee to the Assignor under the SPA, the Assignor hereby assigns as registered and beneficial owner absolutely to the Assignee free from all Encumbrances all right, title and interest in and to the Intellectual Property, together with the goodwill attaching to the Intellectual Property and the goodwill of the business in which the Intellectual Property has been used by the Assignor or its licensees including all statutory and/or common law rights attaching thereto and the right to sue for past infringements and to recover and retain any damages and/or profits obtained as a result of such action. In this Assignment, “**Encumbrance**” means any mortgage, charge, pledge, lien, option, restriction, right of first refusal, right of pre-emption, third party right or interest, other encumbrance or security interest of any kind conditional sale or other title transfer or retention arrangement or other restriction of a similar kind, and any agreement or obligation to create or grant any of the aforesaid.
2. The Assignor warrants that it will use its best endeavours to procure and assist in recording this Assignment with the trade mark registries and patent registries in the relevant jurisdictions and shall do and execute or procure that there shall be done and executed all such documents deeds matters acts and things as the Assignee may at any time require in order to properly vest the Intellectual Property in the name of the Assignee.
3. This Assignment is governed by and will be construed in accordance with Hong Kong law. The parties submit to the non-exclusive jurisdiction of the Hong Kong courts and

each party waives any objection to proceedings in Hong Kong on the grounds of venue or inconvenient forum.

4. The service of any process connected with proceedings in the Hong Kong courts and relating to this Assignment will be deemed to have been validly served on a party if they are served on the process agent whose name and present address are set out below against the name of that party and service will be deemed to have been acknowledged by that party if it is acknowledged by that process agent:


