**ASSIGNMENT OF PATENTS, TRADEMARKS, DOMAIN NAMES AND UNLISTED

THIS ASSIGNMENT (this "Assignment") is made as of July 19, 2013, by and among LiveWire Mobile, Inc., a Delaware corporation (the "Company"), Groove Mobile, Inc., a Delaware corporation and indirect, wholly-owned Subsidiary of the Company ("Groove" and together with the Company, the "Sellers"), and OnMobile Live, Inc., a Nevada corporation ("Buyer").

WHEREAS, the Sellers and Buyer are parties to that certain Asset Purchase Agreement dated as of June 1, 2013 (the "Purchase Agreement");

WHEREAS, it is a condition to the consummation of the transactions under the Purchase Agreement that this Assignment be entered into;

WHEREAS, each of the Sellers owns certain patents and patent applications which are listed on Schedule 1 attached hereto (the "Assigned Patents"), certain common law trademarks, registered trademarks and trademark applications which are listed on Schedule 2 attached hereto (the "Assigned Trademarks"), certain domain names which are listed on Schedule 3 attached hereto (the "Assigned Domain Names") and other unlisted Intellectual Property (the "Unlisted IP"), including but not limited to any intellectual property rights associated with inventions, trade secrets, know how, copyrights (registered or unregistered), and copyright protectable subject matter including software and documentation; and

WHEREAS, Buyer desires to receive from the Sellers assignments to the Assigned Patents, Assigned Trademarks, Assigned Domain Names and Unlisted IP;

NOW THEREFORE, for good and valuable consideration, each of the Sellers hereby assigns to Buyer all of (a) such Seller's entire right, title and interest, including the right to sue for and collect past damages, in and to the Assigned Patents, and any and all divisional applications, continuation applications, continuations-in-part, reissues, reexaminations thereof, and all pending applications therefor, which claim priority from any application from which Assigned Patents are derived, as well as, all foreign counterparts of Assigned Patents; (b) such Seller's entire right, title and interest, including the right to sue for and collect past damages, in and to the Assigned Trademarks and all goodwill associated therewith; (c) such Seller's entire right, title and interest, including the right to sue for and collect past damages, in and to the Assigned Domain Names and all goodwill associated therewith; and (d) such Seller's entire right, title and interest, including the right to sue for and collect past damages, in and to the Unlisted IP and all goodwill associated therewith.

Each of the Sellers hereby authorizes the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office, and the empowered officials of any other applicable offices and governments, to issue or transfer all applicable Assigned Patents, Assigned Trademarks and Unlisted IP to Parent, as assignee thereof, or otherwise as Parent may direct.
