Assignor agrees that it will execute such documentation as may be necessary in the future to effectuate this Assignment.

This instrument shall be governed by and interpreted under the laws of the State of New York, without regard to the conflicts of laws principals thereof.

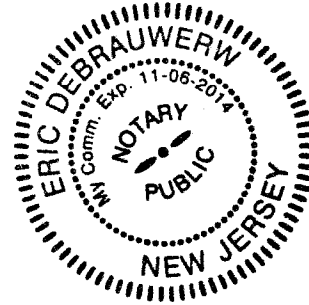

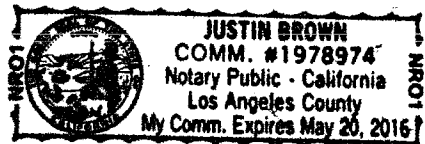

INSTRUCTIONS FOR COMPLETING THIS FORM
