**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks, dated as of July 28, 2011 (the "Third Lien Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 004610, Frame 0029 on August 23, 2011, by National Tobacco Company, L.P. ("Releasee"), to U.S. Bank National Association, in its capacity as Third Lien Notes Collateral Agent under the Third Lien Notes Security Agreement ("Releasor"), Releasee assigned to Releasor as collateral security, and granted to Releasor a continuing security interest in, to and under the trademarks and trademark registrations and applications therefor and service marks listed on Schedule A of the Third Lien Trademark Security Agreement, together with, among other things, the good-will of the business with which the Trademarks are associated, and all Proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Trademark Collateral"); and

WHEREAS, Releasee has requested, and Releasor has agreed to execute, acknowledge and deliver, this Release of Security Interest in Trademarks to confirm the release, relinquishment and discharge of its continuing security interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. **Defined Terms.** All capitalized terms used but not otherwise defined herein have the meanings given to them in the Third Lien Trademark Security Agreement.
2. **Release of Security Interest.** Releasor hereby, without any representation or warranty and without any recourse to Releasor, terminates the Third Lien Trademark Security Agreement and releases, relinquishes and discharges its continuing security interest in, to and under the Trademark Collateral and retransfers and reassigns to Releasee any right, title or interest Releasor may have in, to and under the Trademark Collateral.
