RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of July 28, 2009 (as amended, restated, supplemented, or otherwise modified from time to time, the "<u>Trademark Security Agreement</u>"), by and among Grantors and Agent, Grantors granted to Agent a security interest in all of Grantors' right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement, the "<u>Original Trademark Collateral</u>");

WHEREAS, pursuant to the terms and conditions of that certain Amendment Number One to Trademark Security Agreement dated as of March 11, 2011 ("First Amendment") by and among Grantors and Agent, Grantors granted to Agent a security interest in all of Grantors' right, title and interest in and to the Additional Trademark Collateral (as such term is defined in the First Amendment, the "First Amendment Trademark Collateral");

WHEREAS, pursuant to the terms and conditions of that certain Amendment Number Two to Trademark Security Agreement dated as of October 31, 2012 ("Second Amendment"; together with the First Amendment and Trademark Security Agreement, collectively, the "Trademark Documents") by and among Grantors and Agent, Grantors granted to Agent a security interest in all of Grantors' right, title and interest in and to the Additional Trademark Collateral (as such term is defined in the Second Amendment, the "Second Amendment Trademark Collateral" and together with the Original Trademark Collateral and the First Amendment Trademark Collateral, collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on July 29, 2009 at Reel 004034, Frame 0190;

WHEREAS, the First Amendment was recorded with the USPTO on March 11, 2011, at Reel 004497, Frame 0163;

WHEREAS, the Second Amendment was recorded with the USPTO on November 1, 2012, at Reel 004892, Frame 0338; and

WHEREAS, Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on <u>Schedule 1</u> hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Documents and reassigns to Grantors all right, title, and interest of Agent in the Trademark Collateral pursuant to the Trademark Documents.
