# Trademark Assignment

This trademark assignment (this "Assignment") is entered into on November \_\_\_\_, 2013, BY AND BETWEEN:

- (1) GAFP, INC. (formerly known as AMERISTAR FENCE PRODUCTS INC.), doing business as 440 FENCE COMPANY INC. an Oklahoma corporation (the "Assignor"); and
- (2) AMERISTAR PERIMETER SECURITY USA INC. (formerly known as COIL USA INC.), a Delaware corporation (the "Assignee").

#### Whereas:

- (A) The Assignor is the owner of the Trademarks (as defined below).
- (B) The Assignor and Assignee and certain of their affiliates entered into that certain Asset Purchase Agreement, dated as of September 30, 2013, (the "Asset Purchase Agreement"), pursuant to which the Assignor agreed to sell, assign, transfer, convey and deliver to the Assignee all of its right, title and interest in, to and under the Owned Intellectual Property (as defined in the Asset Purchase Agreement), on the terms and subject to the conditions set forth in the Asset Purchase Agreement.
- (C) The Owned Intellectual Property includes the Trademarks.
- (D) The Assignor and Assignee now desire to enter into this Assignment to effect the sale, assignment, transfer, conveyance and delivery to the Assignee of the Trademarks on the terms and conditions of this Assignment.

### It is agreed as follows:

### 1 Interpretation

1.1 Capitalized words used in this Assignment and not defined in Section 1.2 below shall have the same meanings as in the Asset Purchase Agreement.

#### 1.2 **Definitions**

"Trademarks" means the registered trademarks and applications for registered trademarks listed in Part A of Schedule 1 to this Assignment and the unregistered trademarks listed in Part B of Schedule 1, all common law rights therein and all goodwill associated therewith.

#### 2 Assignment

In consideration of the representations, warranties and covenants and agreements set forth herein and in the Asset Purchase Agreement and for other good and

valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each party, the Assignor hereby sells, assigns, transfers, conveys and delivers to the Assignee:

- all of the Assignor's right, title and interest in, to and under all Trademarks, together with the goodwill of the business connected with the use of and symbolized by said Trademarks and together with that portion of Assignor's business that pertains to the intent-to-use applications included therein and filed pursuant to Section 1(b) of the United States Trademark Act (15 U.S.C. § 1051, et seq.), including without limitation the absolute entitlement to any registered trademarks granted pursuant to any of the applications comprised in the Trademarks, and all registrations and pending applications for registration of said Trademarks, and together with all rights appurtenant to said Trademarks, including without limitation all common law rights therein; and
- 2.2 any and all interests, claims and rights for damages and profits by reason of any past, present and/or future infringement or unauthorized use of the Trademarks, false designations of origin, unfair competition, deceptive trade practices and/or dilution related to the Trademarks, use of confusingly similar marks or names by others and all other related causes of action and the right to sue therefor.

#### 3 **Due authorization**

The Assignor hereby authorizes the Assignee to request, and the Assignor and Assignee hereby request, that the U.S. Patent and Trademark Office, and any other applicable Governmental Authority, record in the name of the Assignee all trademark registrations and applications for trademark registrations included in the Trademarks and issue in the name of the Assignee any and all trademark registrations from any and all applications for trademark registrations included in the Trademarks.

### 4 Further Assurances

Any time after the date of this Assignment, at the request of the Assignee, the Assignor shall:

- 4.1 execute all such documents and do such acts and things as the Assignee may reasonably require in order to give to the Assignee the full benefit of all the provisions of this Assignment; and
- 4.2 provide all reasonable assistance which the Assignee considers necessary in connection with bringing or defending any proceedings in relation to the Trademarks or with the prosecution of any applications to register the Trademarks or with establishing, confirming or defending title to the Trademarks.

#### 5 Costs

Any reasonable costs incurred by the parties pursuant to this Assignment, including any costs associated with recording the transactions contemplated by this Assignment at the U.S. Patent and Trademark Office, or any other applicable Governmental Authority, shall be shared equally between the Assignor on the one hand and the Assignee on the other hand.

### **6** Entire Agreement

This Assignment, the Asset Purchase Agreement and the schedules, exhibits and annexes hereof and thereof contain the entire agreement and understanding of the parties hereto with respect to the subject matter hereof and thereof, and supersede all prior written or oral negotiations, understandings and agreements relating to the subject matter hereof. To the extent that any provision of this Assignment is inconsistent with the provisions of the Asset Purchase Agreement, the provisions of the Asset Purchase Agreement shall prevail.

### 7 Successors and Assigns

This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns. Assignee, its successors and assigns shall hereafter hold all of the aforesaid rights in the same manner in which they would have been held by Assignor had this Assignment not been made.
