SECURITY GRANT – TRADEMARKS

January 24, 2014

WHEREAS, SIMPLISAFE, INC., a Delaware corporation (the “Grantor”), holds all right, title and interest in and to, the trademarks listed on the annexed Schedule 1, which trademarks are registered or applied for in the United States Patent and Trademark Office (the “Trademarks”);

WHEREAS, the Grantor has entered into an Intellectual Property Security Agreement, dated as of January 24, 2014 (by and among the Grantor, Grantee (as defined below) and the other Pledgors (as defined therein) from time to time party thereto, as the same may be amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the “Security Agreement”), in favor of CapitalSource Bank, in its capacity as agent for certain lenders (the “Grantee”);

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Grantee for the benefit of the lenders a continuing security interest in all right, title and interest of the Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor grants to the Grantee for the benefit of the lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


