Ladies and Gentlemen:

Reference is hereby made to that certain Second Amended and Restated Credit Agreement dated as of January 19, 2011 (as amended, supplemented or otherwise modified, the "Credit Agreement"; unless otherwise defined herein, capitalized terms used herein shall have the meanings ascribed to such terms in the Credit Agreement) by and among **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company, as an administrative agent (the "US Administrative Agent") for the Lenders, the lenders party thereto (the "Lenders"), **WELLS FARGO FINANCIAL CORPORATION CANADA**, a Nova Scotia unlimited company, as an administrative agent for the Lenders ("Canadian Administrative Agent" together with US Administrative Agent, collectively, "Agents" each a "Agent"), **AS AMERICA, INC.**, a Delaware corporation (as successor by merger to Crane Plumbing LLC, Eljer, Inc., Crane Plumbing Holding Corp., Eljer Holding Corp., URC Enterprises LLC and NewArtesian Transportation LLC) ("AS America"), **DECORATIVE PANELS INTERNATIONAL, INC.**, a Delaware corporation ("DPI"), **SAFETY TUBS COMPANY, LLC**, a Delaware limited liability company ("Safety Tubs"), **AS LOGISTICS, INC.**, a Delaware corporation ("AS Logistics"; AS America, AS Logistics, Safety Tubs and DPI are referred to hereinafter each individually as a "US Borrower", and collectively as the "US Borrowers"), **AS CANADA, ULC**, a Nova Scotia unlimited company ("AS Canada"), and **CRANE PLUMBING CANADA CORP.**, a Canada corporation ("Crane Canada"; AS Canada and Crane Canada are referred to hereinafter each individually as a "Canadian Borrower", and collectively as the "Canadian Borrowers"; US Borrowers and Canadian Borrowers are referred to hereinafter each individually as a "Borrower" and collectively as the "Borrowers"), **ASD PLUMBING HOLDINGS, LLC**, a Delaware limited liability company (formerly known as ASD Plumbing Holding Corp.) ("Parent"), **ASD HOLDING CORP.**, Delaware corporation ("ASD Holding"), and **CRANE PLUMBING CANADA HOLDING CORP.**, a Delaware corporation ("Crane Canada Holding"; ASD Holding and Crane Canada Holding are referred to hereinafter each individually as a "Holdco" and collectively as the "Holdcos"). Further reference is made to **DPI SPV, LLC**, a Delaware limited liability company ("DPI SPV"), **AS HOLDCO, LLC**, a Delaware limited liability company ("AS Holdco"), **AS IP HOLDCO, LLC**, a Delaware limited liability company ("AS IP Holdco"), **DECORATIVE PANELS HOLDING CORP.**, a Delaware corporation ("DPHC"), **AS CANADA HOLDING CORP.** an Ontario corporation ("AS Canada Holding"), and SAU

CORP., a Delaware corporation ("Sau Corp." together with DPI SPV, AS Holdco, AS IP Holdco, DPCH, AS Canada Holding and Holdcos are the "Guarantor" each a "Guarantor") which each guaranteed the obligations of US Borrowers and/or Canadian Borrowers, as applicable; Borrowers, Guarantors, and Parent are collectively "Companies" and individually a "Company".

Agents have been informed by Companies that certain of the Companies will be entering into a transaction and in connection therewith all of the liabilities, obligations and indebtedness owing by Companies to Agents and the Lenders under the Credit Agreement, other than the "Letter of Credit Obligations" (as defined below) and the "Surviving Obligations" (as defined below), will be paid off. If received by 5:00 p.m. (New York time) on January 10, 2014, the amount necessary to pay all of the liabilities, obligations and indebtedness owing by Companies to Agents and the Lenders under the Credit Agreement (other than the Letter of Credit Obligations and Surviving Obligations) is the sum of:

- (A) \$24,607.94 (the "US Payoff Amount") of which \$322.04 constitutes interest and principal, \$9,285.63 constitutes unpaid fees and \$15,000.27 constitutes unpaid fees and expenses in respect of Agent's Canadian counsel (provided, that the US Payoff Amount shall be increased by a per diem amount of \$754.00 (the "US Per Diem") for each day after 5:00 p.m. (New York time) on January 10, 2014, until the Payoff Date (as defined below), in respect of daily accruals of interest and fees); and
- (B) \$1,406.75 (the "Canadian Payoff Amount") of which \$0.50 constitutes interest and principal, \$1,406.25 constitutes unpaid fees and (provided, that the Canadian Payoff Amount shall be increased by a per diem amount of \$156.25 (the "Canadian Per Diem") for each day after 5:00 p.m. (New York time) on January 10, 2014, until the Payoff Date (as defined below), in respect of daily accruals of interest and fees).

"Letter of Credit Obligations" means the obligations of Companies under the Credit Agreement and other Loan Documents in respect of Letters of Credit shown on Exhibit C hereto and fees, charges, costs and expenses with respect thereto. "Surviving Obligations" means (i) the obligations of Companies under the Credit Agreement and other Loan Documents (including indemnification obligations) that by the terms of the Credit Agreement and other Loan Documents survive the termination of the Credit Agreement, and (ii) obligations of Companies under this letter to reimburse Agents and the Lenders for reasonable costs and expenses that may become due and payable after the date hereof.

This letter will confirm that upon (A) receipt by US Administrative Agent by wire transfer of (i) the US Payoff Amount plus the US Per Diem, if any, (ii) cash collateral in the amount of \$3,545,850 (the "L/C Cash Collateral") to secure the Letter of Credit Obligations, and (ii) cash collateral in the amount of \$20,000 (the "Expense Deposit Cash Collateral") to secure the reimbursement of expenses of Agents in connection with the transaction contemplated by this letter (the total of the US Payoff Amount, L/C Cash Collateral and Expense Deposit Cash Collateral is \$3,590,457.94 (provided, that such amount shall be increased by the US Per Diem)), to the following account:

and (D) receipt by Agents of a copy of this agreement duly executed by the Companies (the deliveries described in the foregoing clauses (A) - (D), the "Payoff Deliveries"), the liens and security interests of Agents in any and all of the property of Companies (other than the L/C Cash Collateral and Expense Deposit Cash Collateral) that secure the obligations under the Credit Agreement shall be deemed to be released and terminated and all liabilities, obligations and indebtedness owing by Companies to Agents and the Lenders under the Credit Agreement (other than the Letter of Credit Obligations and Surviving Obligations), shall be deemed to have been satisfied in full and all guarantees under the Credit Agreement and other Loan Documents shall be terminated. The date that all of the Payoff Deliveries are received by Agents is the "Payoff Date". If the assumptions set forth with respect to the calculation of any amount set forth in clause (A) above is not correct, Agents will notify Companies in writing before the Payoff Date of the appropriate changes in such amounts and such adjusted amounts shall be required to be paid hereunder. This letter shall not be effective if all of the Payoff Deliveries are not received by Agents on or before 5:00 p.m. (New York time), January 17, 2014. Subject to receipt of all of the Payoff Deliveries, (i) Agents authorizes Companies and/or its designees to terminate or discharge, as applicable the UCC Financing Statements and PPSA Financing Statements listed on Exhibit A attached hereto, liens on any intellectual property listed on Exhibit B attached hereto and any mortgages or deeds of trust listed on Exhibit C attached hereto, (ii) Agents hereby waive all notice requirements, if any, under the Loan Documents for voluntary prepayments of any Loans, (iii) Agents shall promptly deliver to AS America any other termination statements and mortgage releases, as applicable, pertaining to any liens and security interests of Agents in any of the property of Companies, as AS America may reasonably request, in connection with

Agents' above-described release and termination of its security interests and liens, (iv) Agents shall promptly deliver to AS America (a) the collateral in each Agent's possession and listed on Exhibit D, and (b) the originals of any and all promissory notes previously delivered to the Agents and/or Lenders by the Companies in connection with the Loan Documents, duly marked "paid in full" or "cancelled" (or with written authorizations to so mark such documents after the Payoff Date actually occurs), and (v) Agents shall provide written notice to any financial institution at which a Company maintains a deposit account subject to a control agreement in favor of either Agent that such Agent no longer requires control of such deposit account. Companies shall reimburse Agents, on demand, for any reasonable costs and expenses incurred by Agents in connection with the release and termination of its liens. Companies shall continue to be obligated with respect to the Letter of Credit Obligations and Surviving Obligations and to pay Agents, Issuing Lenders and the Lenders the fees, charges, costs and expenses associated with the Letters of Credit in accordance with the terms of the Credit Agreement.

Each Company acknowledges and agrees that:

(i) the amounts referred to above are enforceable obligations of the Companies payable to Agents and the Lenders pursuant to the provisions of the Credit Agreement and the other Loan Documents without any deduction, offset, defense or counterclaim;

(ii) prior to the Payoff Date, nothing contained herein shall constitute a waiver of any Default or Event of Default or of Agents' and the Lenders' rights and remedies under the Credit Agreement or any other Loan Document; and

(iii) as of the Payoff Date, Agents, the Lenders, Issuing Lenders and their respective participants, if any, shall have no further (A) commitment to provide loans or letters of credit or other financial accommodations under the Credit Agreement or the other Loan Documents or (B) obligation, duty or responsibility under the Credit Agreement, any other Loan Document or any other document or agreement executed and/or deliver in connection therewith.

In the event that in calculating the US Payoff Amount and Canadian Payoff Amount, Agents gave credit to any check or other item of payment received from Companies or constituting proceeds of Collateral by applying the amount thereof to the Obligations and such check or other item of payment is subject to a claim or refund, or is reversed or returned for any reason (including insufficient funds or non-payment), Companies jointly and severally agree to reimburse and pay, on demand, to Agents the amount of any such check or other item of payment, together with any losses, liabilities, charges, expenses and fees associated therewith. Companies jointly and severally further agree to reimburse and pay, on demand, to Agents any amounts required to be paid by Agents, whether as an indemnification payment or otherwise, under any lockbox, blocked account or account control arrangement entered into by Agents in connection with the Credit Agreement or other Loan Documents, together with any losses, liabilities, charges, expenses and fees associated therewith. Companies jointly and severally further agree to reimburse and pay, on demand, to Agents (i) any reasonable and documented amounts which Agents and the Lenders may have incurred or may now or hereafter incur in connection with the transactions contemplated hereby which have not as yet been reflected in Companies' loan accounts which Companies are, or may be, required to bear pursuant to the

Credit Agreement and other Loan Documents and/or (ii) any documented amounts which Agents and the Lenders may incur as a result of errors in calculation of any amounts due Agents and the Lenders by Companies.

The L/C Cash Collateral and Expense Deposit Cash Collateral shall be held in a deposit account (the "Cash Collateral Account") in the name of US Administrative Agent. Each Company hereby grants to US Administrative Agent, for the benefit of itself, Issuing Lenders and the Lenders, a security interest in and lien upon (a) the L/C Cash Collateral and all proceeds thereof, if any, to secure (i) the reimbursement obligations of Borrowers in respect of the Letters of Credit, and (ii) the obligations of Borrowers to pay certain fees, charges and expenses with respect to the administration of the Letters of Credit in accordance with the Loan Documents, and (b) the Expense Deposit Cash Collateral and all proceeds thereof, if any, to secure the obligations of Companies to reimburse Agents for reasonable and documented expenses incurred in connection with or transactions contemplated by this letter. Amounts held in the Cash Collateral Account may be commingled with other funds at the option and sole discretion of US Administrative Agent. US Administrative Agent shall have the rights and remedies of a secured party under the Uniform Commercial Code in respect of the Cash Collateral Account, L/C Cash Collateral and Expense Deposit Cash Collateral and shall be entitled to debit the Cash Collateral Account at any time to honor any acceptances and drawings made under the Letters of Credit, satisfy any due and unpaid fees, charges and expenses associated with the Letters of Credit, and satisfy any expenses incurred by Agents in connection with the transactions contemplated by this letter. Within five (5) business days after the expiration, drawing or replacement of all of the Letters of Credit, after payment of all unpaid obligations relating thereto, US Administrative Agent shall pay to AS America any L/C Cash Collateral remaining in the Cash Collateral Account. Within ninety (90) days following the date hereof, US Administrative Agent shall pay to AS America any Expense Deposit Cash Collateral remaining in the Cash Collateral Account. Any funds transferred to AS America from US Administrative Agent pursuant to this paragraph shall be by wire transfer to such account as is designated in writing to US Administrative Agent by AS America.

Each Company, on behalf of itself and its successors, assigns, and other legal representatives (each Company and all such other parties collectively, the "Releasors" and individually, a "Releasor"), hereby jointly, severally, and jointly and severally, absolutely, unconditionally and irrevocably releases, remises and forever discharges each Agent and each Lender, its successors and assigns, and its present and former shareholders, affiliates, subsidiaries, divisions, predecessors, directors, officers, attorneys, employees, agents and other representatives (Agents, each Lender and all such other parties collectively, the "Releasees" and each a "Releasee"), of and from all demands, actions, causes of action, suits, covenants, contracts, controversies, agreements, promises, sums of money, accounts, bills, reckonings, damages and any and all other claims, counterclaims, defenses, rights of set-off, demands and liabilities whatsoever (individually, a "Claim" and collectively, "Claims") of every name and nature, known or unknown, suspected or unsuspected, both at law and in equity, which any Releasor may now or hereafter own, hold, have or claim to have against the Releasees or any of them for, upon, or by reason of any nature, cause or thing whatsoever which arises at any time on or prior to the date of this letter, for or on account of, or in relation to, or in any way in connection with the Credit Agreement and Loan Documents, as amended and supplemented through the date hereof.

The parties hereto agree that no further Revolving Loans or other extension of credit may be made or requested, and no further Letters of Credit may be requested or issued, on or after the date hereof.


If any payment or transfer (or any portion thereof) to Agents, any Lender, Issuing Lenders or any of their respective participants shall be subsequently invalidated, declared to be fraudulent or a fraudulent conveyance or preferential, avoided, rescinded, set aside or otherwise required to be return or repaid, whether in bankruptcy, reorganization, insolvency or similar proceedings involving any Company or otherwise, then the obligations purportedly satisfied with such payment or transfer shall immediately be reinstated, without need for any action by any Person, and shall be enforceable against the Companies and their successors and assigns as if such payment had never been made (in which case this letter agreement shall in no way impair the claims of Agents, the Lenders, Issuing Lender and their respective participants with respect to such payment or transfer).

Notwithstanding anything contained herein to the contrary, nothing contained herein shall affect the liabilities, obligations or indebtedness of Companies to Wells Fargo Bank, National Association with respect to any deposit accounts, cash management arrangements and foreign exchange transactions, cross currency rate swap, currency option or any other currency swap hedge or swap.

This letter may be signed in multiple counterparts, each of which shall constitute an original and all of which, taken together, shall constitute one and the same instrument. One or more counterparts of this letter may be delivered by facsimile, with the intention that they shall have the same effect as an original counterpart thereof.
