NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), effective as of February 3, 2014 is made by U.S. Bank National Association, as Collateral Agent (the "Collateral Agent"), in favor of Lucky Brand Dungarees, Inc., a Delaware corporation (the "Company"), pursuant to an indenture dated April 7, 2011 (as amended, restated, supplemented or modified from time to time, the "Indenture") among the Company, each Guarantor (as defined in the Indenture), and the Collateral Agent, in which the Company has issued to the Holders the 10.5% Senior Secured Notes due 2019 (together with any exchange notes and additional notes, the "Notes") pursuant to the Indenture.

WHEREAS, pursuant to the Indenture, the Company has issued to the Holders the Notes upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Indenture, the Company and the other grantors party thereto, have executed and delivered in favor of the Collateral Agent (i) a Pledge and Security Agreement, dated as of April 7, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement"), (ii) a Notice of Grant of Security Interest in Trademark Rights, dated as of April 7, 2011, recorded in the United States Patent and Trademark Office (the "USPTO") on April 12, 2011 at Reel/Frame No. 4519/0612 and (iii) a Notice of Grant of Security Interest in Trademark Rights, dated as of April 18, 2013, recorded in the USPTO on April 24, 2013 at Reel/Frame No. 5013/0526 ((ii) and (iii) being the "Notices" and together with the Pledge and Security Agreement, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Company pledged and granted to the Collateral Agent for the benefit of the Collateral Agent and the Secured Parties a continuing security interest in all of their intellectual property, including but not limited to the trademarks, service marks and trademark and service mark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, Fifth & Pacific Companies, Inc. has agreed to dispose of all the issued and outstanding stock of the Company under that certain Stock Purchase Agreement, dated as of December 10, 2013, by and between LBD Acquisition Company, LLC, a Delaware limited liability company and Fifth & Pacific Companies, Inc., a Delaware corporation (the "Purchase Agreement");

WHEREAS, in connection with the Purchase Agreement, the Company has requested that the Collateral Agent release any and all right, title and interest it may have in the Released Trademarks pursuant to the Security Agreements, and the Collateral Agent has agreed to do so; and

WHEREAS, the Collateral Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees, for the benefit of the Company, as follows:

- SECTION 1. <u>Definitions</u>. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Indenture and Security Agreements, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Security Agreements).
- SECTION 2. <u>Release of Security Interest</u>. The Collateral Agent does hereby release, relinquish, terminate in its entirety and discharge its continuing security interest in all of the Company's right, title and interest in, to and under the Released Trademarks.
- SECTION 3. <u>Purpose</u>. This Release has been executed and delivered by the Agent for the purpose of recording this Release with the USPTO and is subject to the conditions set forth in the Letter Release among U.S. Bank National Association, as Collateral Agent, Fifth & Pacific Companies, Inc., the Company and certain other persons dated the date hereof. The Indenture and the Pledge and Security Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.
- SECTION 4. <u>Further Assurances</u>. The Collateral Agent hereby authorizes the Company or the Company's authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Collateral Agent further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or their agents or designees) reasonably request (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Released Trademarks.
- SECTION 5. <u>Choice of Law</u>. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.
- SECTION 6. <u>Counterparts</u>. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
