RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this ___ day of January, 2014, given by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, with an address at 1525 West W.T. Harris Boulevard, Charlotte, North Carolina 28262, as Collateral Agent ("Agent") to Health Management Associates, Inc., a Delaware corporation ("Health Management") and Hospital Management Associates, Inc., a Florida corporation ("Hospital Management"), and together with Health Management, the "Grantors").

WITNESSETH

WHEREAS, pursuant to that certain Credit Agreement dated as of November 18, 2011 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to make certain financial accommodations to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantors executed that certain Security Agreement, dated as of November 18, 2011 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") and granted to the Agent a continuing priority security interest in and to all Grantor's right, title and interest in all United States trademarks, trademark registrations and trademark applications and any renewals thereof, including as set forth on Schedule A attached hereto (collectively, the "Trademarks") to secure the Secured Obligations;

WHEREAS, in furtherance of the Security Agreement, the Grantors executed a Trademark Security Agreement, dated November 18, 2011 (the "Trademark Security Agreement"), which was duly recorded on November 18, 2011, at Reel 4662 / Frame 0949 in the United States Patent and Trademark Office;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantors and to dissolve those Liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby grants, assigns and conveys, without recourse or warranty, to the Grantors all of its rights, title and interest in the Trademarks, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantors any and all security interests or liens it has against the Trademarks.
