RELEASE OF GRANT OF A SECURITY INTEREST -- TRADEMARKS

WHEREAS, pursuant to that certain Grant of A Security Interest – Trademarks (the "Trademark Security Agreement"), dated as of March 22, 2011, recorded in the United States Patent and Trademark Office on March 29, 2011 at Reel 004510, Frame 0457, and supplemented by that certain Supplemental Grant of a Security Interest - Trademarks (the "First Supplemental Trademark Security Agreement"), dated as of October 16, 2012, recorded in the United States Patent and Trademark Office on October 17, 2012 at Reel 4883, Frame 0099, that certain Supplemental Grant of a Security Interest - Trademarks (the "Second Supplemental Trademark Security Agreement"), dated as of March 11, 2013, recorded in the United States Patent and Trademark Office on March 14, 2013 at Reel 4982, Frame 0353 and that certain Supplemental Grant of a Security Interest - Trademarks (the "Third Supplemental Trademark Security Agreement"), dated as of July 19, 2013, recorded in the United States Patent and Trademark Office on July 19, 2013 at Reel 5074, Frame 0505, Marine Acquisition Corp., ("Releasee") granted to Ableco Finance LLC ("Releasor"), in its capacity as Collateral Agent for itself and certain lenders, a continuing security interest in all right, title and interest of the Releasee in, to and under the Trademarks, including the Trademarks listed on Schedule A attached hereto, together with, among other things the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the Collateral.
