GRANT OF TRADEMARK SECURITY INTEREST

WHEREAS, FC Operating, LLC, a Georgia limited liability company (the "Grantor"), owns and uses in its business, and will in the future adopt and so use, various intangible assets, including Trademarks (as each are defined below); and

WHEREAS, pursuant to a Term Loan Credit Agreement dated as of November 14, 2012, (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Grantor, Family Christian Operating Holding, LLC, a Georgia limited liability company ("Holdings") and FCS Giftco, LLC, a Colorado limited liability company ("Giftco"), and each other Subsidiary Guarantor party thereto, the Lenders party thereto (the "Lenders") and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent and Collateral Agent, the Lenders have agreed to make Loans to and make other extensions of credit on behalf of the Grantor (capitalized terms used but not defined herein have the respective meanings assigned to them in the Credit Agreement); and

WHEREAS, pursuant to the terms of the Pledge and Security Agreement dated as of November 14, 2012 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Grantor, Holdings, Giftco, and each other Subsidiary Party (as defined in the Security Agreement) and Credit Suisse AG, Cayman Islands Branch, as Collateral Agent for each of the Secured Parties (as defined in the Security Agreement) (in such capacity, the "Agent"), Grantor has agreed to grant in favor of the Agent a security interest in, and the Agent has agreed to become a secured creditor with respect to Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, Grantor hereby grants to the Agent a security interest in all of Grantor's right, title and interest in and to Trademarks, whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located.

As used herein, "Trademarks" means:

(a) all common law trademarks, trademark registrations and trademark applications, common law service marks, service mark registrations and service mark applications, trade names, corporate names, trade dress and logos, and the goodwill of the business symbolized by the foregoing, including but not limited to those registrations and applications listed on Schedule A, and all goodwill associated therewith; (b) all extensions and renewals of the foregoing; (c) all income, royalties, damages and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof; (d) all rights to sue for past, present and future infringements of the foregoing; (e) all rights corresponding to any of the foregoing throughout the world; and (f) any and all licensing agreements or similar arrangements in and to any of the foregoing to the extent in each case such agreements and arrangements now or hereafter owned by Grantor.


Notwithstanding anything herein to the contrary, in no event shall Trademarks include, and Grantor shall not be deemed to have granted a security interest in, any of Grantor's rights or interests in (i) any intent to use trademark application, or (ii) any license, contract or agreement to which Grantor is a party or any of its rights or interests thereunder to the extent, but only to the extent, that such a grant would, under the terms of such license, contract or agreement or otherwise, result in a breach of the terms of, or constitute a default under any license, contract or agreement to which Grantor is a party; provided, that immediately upon the ineffectiveness, lapse or termination of any such provision, Trademarks shall include, and Grantor shall be deemed to have granted a security interest in, all such rights and interests as if such provision had never been in effect.

Grantor further acknowledges that the rights and remedies of the Agent with respect to the security interest in Trademarks granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
