WHEREAS, pursuant to that certain Credit and Guaranty Agreement dated as of August 1, 2011 and Amended and Restated Credit and Guaranty Agreement dated as of July 2, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, collectively, the "Loan Agreement") by and among the Grantors, Agent, and Lenders, and the Patent Security Agreement dated as August 1, 2011 and recorded at the United States Patent and Trademark Office ("USPTO") on August 4, 2011 at Reel 026698 Frame 0929, Supplement to Patent Security Agreement dated as July 2, 2013 and recorded at the USPTO on July 22, 2013 at Reel 030851 Frame 0449; Trademark Security Agreement dated as August 1, 2011 and recorded at the USPTO on August 4, 2011 at Reel 4597 Frame 0310, and Supplement to Trademark Security Agreement dated as July 2, 2013 and recorded at the USPTO on July 22, 2013 at Reel 5075 Frame 0631 (each an "IP Security Agreement", and collectively, the "IP Security Agreements") each by and among the Grantors and Agent, Grantors granted to the Agent, for itself and the benefit of the Lenders, a security interest and continuing lien upon all of Grantors' right, title and interest in, to and upon the Patents, Patent Licenses, Trademarks, and Trademark Licenses (collectively, the "IP Collateral").

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of itself and the Lenders, and Grantors agree as follows:

SECTION 2. Termination and Release. Agent, on behalf of itself and the Lenders, hereby:

(a) absolutely, unconditionally and irrevocably terminates the IP Security Agreements, and any other agreement under which any Grantor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and upon the IP Collateral;

(b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title,

and interest in, to, and upon the IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release with the USPTO at Grantors' expense.

SECTION 3. Further Assurances. Agent, at Grantors' expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the IP Collateral, Agent will, at Grantors' expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.


