GRANT OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Agreement"), dated as of February 11, 2014, is made by the signatories listed below (each, "Grantor"), in favor of **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as collateral agent (in such capacity, the "Collateral Agent") for the several banks and other financial institutions (the "Lenders") from time to time parties to the Credit Agreement, dated as of February 11, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified, replaced or refinanced from time to time, the "Credit Agreement"), among **DPR, LLC**, a Delaware limited liability company ("**Holdings**") and a wholly owned Subsidiary of Southwire Holding Company, a Delaware corporation, **SOUTHWIRE OPERATIONS, LLC**, a Delaware limited liability company ("**Southwire Operations**") and a wholly owned Subsidiary of Holdings, **SOUTHWIRE COMPANY, LLC**, a Delaware limited liability company (formerly known as Southwire Company) (the "**Company**") and a wholly owned Subsidiary of Southwire Operations, **SOUTHWIRE CANADA COMPANY**, a Nova Scotia unlimited company ("**Southwire Canada**") and a wholly owned Subsidiary of Southwire Operations, and **CUBS ACQUISITION CORPORATION**, a Delaware corporation ("**Merger Sub**"; and from and after consummation of the Acquisition, **COLEMAN CABLE, INC.**, a Delaware corporation ("**New Cubs**"); and together with Southwire Operations, Company, and Southwire Canada, the "**Borrowers**", and each a "**Borrower**"), the other Borrowers from time to time party thereto, the lending institutions from time to time party thereto (each a "Lender" and, collectively, the "Lenders"), and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as the Administrative Agent and the Collateral Agent.

W I T N E S S E T H:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and the Issuing Banks have agreed to issue Letters of Credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, each Grantor and any Subsidiaries that become a party thereto, have executed and delivered a Security Agreement, dated as of February 11, 2014 in favor of the Collateral Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, each Grantor has pledged and granted to the Collateral Agent for the benefit of the Collateral Agent and the Secured Parties continuing security interest in all Intellectual Property, including the Trademarks, that is not Excluded Property; and

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make Loans, to induce Issuing Banks to issue Letters of Credit and to induce one or more Lenders or Affiliates of Lenders to enter into Secured Cash Management Agreements or Secured Hedge Agreements with Holdings and/or its Subsidiaries, each Grantor agrees, for the benefit of the Collateral Agent and the Secured Parties, as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and the Security Agreement.

2. Grant of Security Interest. Each Grantor hereby grants a security interest in all of such Grantor's right, title and interest in, to and under the Trademarks that are not Excluded Property (including, without limitation, those items listed on Schedule A hereto), including the goodwill associated with such Trademarks and the right to receive all Proceeds therefrom (collectively, the "Collateral"), to the Collateral Agent for the benefit of the Secured Parties as collateral security for payment and

performance when due of the Obligations; provided that, applications in the United States Patent and Trademark Office to register trademarks or service marks on the basis of such Grantor's "intent to use" such trademarks or service marks will not be deemed to be Collateral unless and until an amendment to allege use or a statement of use has been filed and accepted by the United States Patent and Trademark Office, whereupon such application shall be automatically subject to the security interest granted herein and deemed to be included in the Collateral.

3. Purpose. This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Secured Parties in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.

4. Acknowledgment. Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Parties with respect to the security interest in the Collateral granted hereby are more fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.


5. Termination. This Agreement shall terminate and the security interest in the Collateral shall be released in accordance with Section 6.5 of the Security Agreement.

6. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

7. Governing Law: This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.


