RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this “Release”), dated as of February 20, 2014, is made by General Electric Capital Corporation, a Delaware corporation with an address of 2 Bethesda Metro Center, Suite 600, Bethesda MD 20814, in its capacity as administrative agent (the “Administrative Agent”) for the holders of the Secured Obligations, in favor of JHP Pharmaceuticals, LLC, a Delaware limited liability company with an address of Morris Corporate Center 2, One Upper Pond Road, Parsippany, NJ 07054 (the “Grantor”).

WHEREAS, pursuant to that certain Collateral Agreement, dated February 19, 2013 (the “Collateral Agreement”), by and between the Administrative Agent and the grantors party thereto, including the Grantor, the parties entered into that certain Trademark Security Agreement, dated February 19, 2013 (the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent, for the ratable benefit of the holders of the Secured Obligations, a security interest in all of each Grantor’s rights, title and interest in or to the Trademarks set forth on Schedule A attached hereto (the “Collateral”).

WHEREAS, the Trademark Security Agreement recorded at the United States Patent and Trademark Office on February 21, 2013 at Reel/Frame 4967/0817 (the “Recordation”); and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Collateral, as provided in the Collateral Agreement and the Trademark Security Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent, on its own behalf and on behalf of the holders of the Secured Obligations, hereby relinquishes, terminates, cancels, discharges and releases, and re-assigns and re-transfer to the Grantor, any and all right, title and interest, including the security interest, it may have or have acquired through the Collateral Agreement and the Trademark Security Agreement in the Collateral (together with all of the goodwill associated therewith or symbolized thereby), including but not limited to the Recordation. The Administrative Agent hereby authorizes and requests that this Release be recorded at the United States Patent and Trademark Office, or any other applicable location. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Trademark Security Agreement or the Collateral Agreement. The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at the Grantor’s cost and expense, to more fully and effectively effectuate the purposes of this Release.
