RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of February 26 ______, 2014 ("Effective Date") by and between Bank of Montreal, in its capacity as Administrative Agent, ("Administrative Agent"), in favor of Aptean Holdings, Inc., as successor-in-interest to CDC Software, Inc., and Aptean, Inc., as successor-in-interest to Consona Corporation, Catalyst International, Inc., Pivotal Corporation, Ross Systems, Inc. Saratoga Systems, Inc., and TradeBeam, Inc. (each a "Grantor"), and collectively, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantors and Administrative Agent dated August 6, 2012 (the "<u>Trademark Security Agreement</u>"), Grantors granted to Administrative Agent a continuing first priority security interest in and to all of Grantors' right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States and foreign trademark registrations and applications set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantors and Administrative Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Credit Agreement by and between Consona Holdings, Inc., a Delaware corporation, Consona Parent Co S.à r.l, a Luxembourg société à responsabilité limitée, with registered address at 19, rue de Bitbourg, L-1273 Luxembourg, registered with the Luxembourg Trade and Companies Register under number B169191, Consona Superior Holdings, Inc., a Delaware corporation, Yaletown Acquiror S.à r.l, a Luxembourg société à responsabilité limitée with registered address at 19, rue de Bitbourg, L-1273 Luxembourg, registered with the Luxembourg Trade and Companies Register under number B168013, the other guarantors from time to time party thereto, the several financial institutions from time to time party thereto, Bank of Montreal, a Canadian chartered bank acting through its Chicago branch, as Administrative Agent, and Golub Capital LLC, a Delaware limited liability company as Syndication Agent dated August 6, 2012 (the "Credit Agreement"):

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on August 6, 2012, at Reel 4836, Frame 0176; and

WHEREAS, Grantors have paid all of their outstanding indebtedness to Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates the Trademark Security Agreement and the Credit Agreement, and hereby terminates, discharges, cancels and releases any and all security interests it has against the Trademark Collateral.

Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an
