RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST is made effective as of February 28, 2014, by and from MORGAN STANLEY SENIOR FUNDING, INC., for itself and as Administrative Agent for the Secured Parties (the "Administrative Agent") to AMS RESEARCH CORPORATION, a Delaware corporation (the "Grantor") as follows:

WHEREAS, on June 17, 2011, Endo Pharmaceuticals Holdings Inc. (the "Borrower"), the Grantor, certain Subsidiaries of the Borrower and the Administrative Agent entered into a Pledge and Security Agreement (the "Security Agreement") and the Grantor and Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, the Confirmatory Grant was recorded in the United States Patent & Trademark Office on July 21, 2011 at reel/frame 004587/0418; and


WHEREAS, the Administrative Agent wishes to release its security interest in the all of the foregoing.
