**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of March 13, 2014, is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, successor by merger to Wilmington Trust FSB, as Collateral Trustee (the "Collateral Trustee"), pursuant to (i) that certain Collateral Trust Agreement, dated as of June 5, 2009 (as amended, the "Collateral Trust Agreement"), among Cricket Communications, Inc., a Delaware corporation (the "Company"), the Guarantors (as defined therein) from time to time party thereto, the Secured Debt Representatives (as defined therein) from time to time party thereto and the Collateral Trustee, (ii) that certain Security Agreement, dated as of June 5, 2009 (the "Security Agreement"), from the Grantors (as defined therein) to the Collateral Trustee, and (iii) that certain Intellectual Property Security Agreement, dated as of June 5, 2009 (the "IP Security Agreement"), from the Grantors (as defined therein) to the Collateral Trustee. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

**W I T N E S S E T H**

WHEREAS, the Company, Leap Wireless International, Inc. and Cricket License Company, LLC (formerly known as Cricket Licensee (Reauction), LLC, and successor by merger to Cricket Licensee I, LLC, and Cricket Licensee 2007, LLC) (collectively, the "Grantors") executed the IP Security Agreement, recorded with the U.S. Patent and Trademark Office on June 9, 2009 at Reel/Frame Nos. 22793/0850 and 4001/0841, pursuant to which the Grantors granted to the Collateral Trustee a lien on and a security interest in all of Grantors' right, title and interest in and to the Collateral (as defined in the IP Security Agreement); and

WHEREAS, in connection with the payment in full and discharge of all outstanding Secured Debt and all other outstanding Secured Obligations (as such terms are defined in the Collateral Trust Agreement) on the date hereof, the Grantors have requested that the Collateral Trustee release all of its security interests in and to the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Trustee agrees as follows:

1. The Collateral Trustee, on its own behalf and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Security Agreement and IP Security Agreement in the Collateral, including, but not limited to, the issued patents and patent applications and trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference (the "Released Collateral").
2. The parties hereto shall cause this Release to be filed with the United States Patent and Trademark Office for the purpose of recording the release of the Secured Parties' security interest in the Released Collateral.
3. The Collateral Trustee agrees, at the request and expense of the Company, to provide the Grantors with any additional authorization necessary to effect the release of the Collateral Trustee's security interest in the Released Collateral.

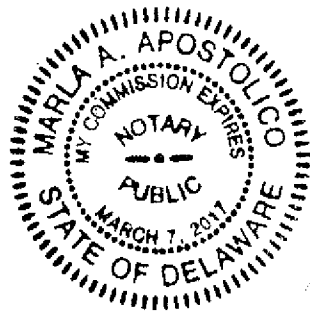


