**TRADEMARK SECURITY AGREEMENT**

This Trademark Security Agreement (this "Trademark Security Agreement"), dated as of March 28, 2014, by Sterling Mets, L.P., a Delaware limited partnership, (the "Pledgor"), in favor of JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent").

**WITNESSETH:**

WHEREAS, the Pledgor is party to that certain Guarantee and Collateral Agreement, dated as of March 28, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") among the Pledgor, Mets Limited Partnership, a Delaware limited partnership, BA Baseball Company, L.L.C., a New York limited liability company, Sterling Facility Services, L.L.C., a New York limited liability company, Mets Development Company, L.L.C., a New York limited liability company, Sterling Mets Operations, L.L.C., a New York limited liability company, Sterling Mets Front Office, L.L.C., a New York limited liability company, CF Hospitality, L.L.C., a New York limited liability company, and certain other Subsidiaries of the Pledgor party thereto from time to time in favor of the Collateral Agent, pursuant to which the Pledgor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Pledgor hereby agrees with the Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the respective meanings ascribed to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Pledgor hereby pledges and grants to the Collateral Agent, for the benefit of the Secured Parties (subject, as to priority, only to MLB Liens and Permitted Prior Liens), a lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral of the Pledgor (collectively, the "Trademark Collateral"):

- (a) Trademarks of such Pledgor listed on Schedule 1 attached hereto;
- (b) all goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Security Agreement, and the Pledgor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Termination. Section 7.13 of the Security Agreement is hereby incorporated by reference herein as if fully set forth herein.

SECTION 5. MLB Requirements. Section 7.15 of the Security Agreement is hereby incorporated by reference herein as if fully set forth herein.

**SECTION 6. GOVERNING LAW. THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK (WITHOUT GIVING EFFECT TO THE PRINCIPLES THEREOF RELATING TO CONFLICTS OF LAW (OTHER THAN SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW (OR ANY SUCCESSOR PROVISION THERETO))).**
