## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of March 25, 2014, by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company located at 100 Park Avenue, 14<sup>th</sup> Floor, New York, New York 10017 (successor by merger to Wachovia Capital Finance Corporation (New England)) in its capacity as agent for the Lender Group and the Bank Product Providers (“**Agent**”), in favor of ESSELTE CORPORATION, a New York corporation located at 225 Broadhollow Road, Suite 300, Melville, New York 11747, and AMERICAN PAD & PAPER LLC, a Delaware limited liability company located at 3101 E. President George Bush Freeway, Suite 200, Richardson, Texas 75082 (each, a “**Grantor**” and, together, the “**Grantors**”). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in that certain Amended and Restated Security Agreement, dated as of August 28, 2012 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Security Agreement**”), among, *inter alios*, the Grantors and Agent.

WHEREAS, reference is made to that certain Amended and Restated Credit Agreement, dated as of August 28, 2012, (the “**Credit Agreement**”), among, *inter alios*, the Grantors, the Lenders (as defined therein) and Agent;

WHEREAS, pursuant to (i) the Security Agreement, (ii) that certain Trademark Security Agreement dated as of June 7, 2010 (the “**Trademark Security Agreement**”) and (iii) that certain Supplemental Trademark Security Agreement dated as of August 28, 2012 (the “**Supplemental Trademark Security Agreement**”, and together with the Trademark Security Agreement, the “**Trademark Security Agreements**”), each Grantor unconditionally granted, assigned and pledged to Agent, for the benefit of each member of the Lender Group and each of the Bank Product Providers, to secure the Secured Obligations, a continuing security interest in all of such Grantor’s right, title and interest in and to the following, whether then owned or thereafter acquired or arising (collectively, the “**Trademark Collateral**”):

- (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party, including those referred to on Schedule A hereto;
- (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and
- (c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties and other compensation under any Trademark Intellectual Property License except to the extent that such Intellectual Property License is an Excluded Asset;

WHEREAS, the Trademark Security Agreement was recorded on June 8, 2010 with the United States Patent and Trademark Office (the “**PTO**”) under Reel and Frame number

4220/0899, and the Supplemental Trademark Security Agreement was recorded on September 17, 2012 with the PTO under Reel and Frame number 4864/0375;

WHEREAS, Grantors are no longer party to the Security Agreement or the Trademark Security Agreements and therefore have no further Secured Obligations with respect to the Trademark Collateral; and

WHEREAS, Grantors have requested that Agent terminate and release its continuing security interest in all of the Grantors' right, title and interest in and to the Trademark Collateral, including those Trademarks set forth on Schedule A hereto.

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent agrees as follows:


- (a) Agent, on behalf of each member of the Lender Group and each of the Bank Product Providers, hereby terminates, relinquishes, releases and discharges fully its security interest in and to the Trademark Collateral.
- (b) Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
- (c) This Release shall be governed by, and construed in accordance with the law of the State of New York.

For the avoidance of doubt, this Release is granted only as to the Grantors and their right, title and interest in the Trademark Collateral. The Credit Agreement, the Security Agreement and the Trademark Security Agreements remain in effect as to the other grantors thereunder and the continuing security interest of Agent in the property of such other grantors is not affected by this Release.
