THIS DEED is made at Singapore on this 1st day of October 2005

Between

Domicil Möbel GmbH, a company incorporated and existing under the laws of the Federal Republic of Germany, whose registered office is at Niederbieger Str. 2, 88250 Weingarten, Germany (hereinafter referred to as "the **Assignor**") of the one part;

And

Domicil International Pte. Ltd., a company incorporated and existing under the laws of the Republic of Singapore, whose registered office is at 11 Gul Circle, Singapore 629567 (hereinafter referred to as "the **Assignee**") of the other part;

WHEREAS

- A The Assignor is and has for some years past been carrying on the Business under the Trade Name.
- B The Assignor is the proprietor of the Trade Marks, the particulars of which are set out in Schedule 1 herein.
- C The Assignor is the proprietor of the Domain Names, the particulars of which are set out in Schedule 2 herein.
- D The Assignor has agreed to assign and transfer the Trade Marks, Domain Names, Trade Name(s) and other Intellectual Property Rights set out herein to the Assignee for good and valuable consideration.
- E The Assignor agrees to assign to the Assignee:
- (i) the Trade Marks together with the goodwill of the Business of the Assignor concerned in the goods or services in respect of which the Trade Marks are registered;
 - (ii) the Domain Names;
 - (iii) the Assignor's rights to the Trade Name(s); and
 - (iv) all other Intellectual Property Rights in relation to the Business upon the terms and conditions hereinafter appearing.


NOW THIS DEED WITNESSETH as follows: -

- 'Intellectual Property Rights' means all other intellectual or industrial property rights in relation to the Business, including but not limited to any copyrights, patents, design rights (in each case whether or not registered or registrable), applications or rights to apply for any of the foregoing, database rights, Know-How, trade marks, trade or business names, domain names, rights in confidential information, trade secrets, goodwill, and all other similar rights not specifically defined herein, existing in any part of the world;
- 'Know-How' means all information, knowledge, experience, formulae, data, and designs in the possession of the Assignor relating to the business, the manufacture and sale of goods, and the offering of specialised services.
- 'Trade Marks' means the registered trade marks set out in Schedule 1, together with all copyrights, design rights and any other intellectual property rights associated with them; and
- 'Trade Name(s)' means the trade name 'Domicil Möbel GmbH' or parts thereof, including any and all translations and variations thereof.
2. Pursuant to this Deed of Assignment and for the valuable consideration (the receipt and sufficiency of which the Assignor hereby acknowledges) provided in the Intellectual Property Asset Sale and Purchase Agreement separately entered into by the Parties on 1 October 2005, the Assignor, as the legal and beneficial owner with full title guarantee, **HEREBY ASSIGNS** absolutely and transfers to the Assignee and its successors the Trade Marks, Domain Names, Trade Name(s) and other Intellectual Property Rights together with the full and exclusive benefit of each of them, including whole of the goodwill of the Business of the Assignor relating to the goods or services for which the Trade Marks are registered and Business is conducted **TO HOLD** the same unto the Assignee absolutely.
3. This assignment shall be governed by the laws of England in every particular including formation and interpretation.
