RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this “**Release**”) is made as of March 31, 2014, among Flint Acquisition Corp., a Delaware corporation, Flint Trading, Inc., a North Carolina corporation, Precision Scan, L.L.C., a North Carolina limited liability company and Ennis Paint, Inc., a Texas corporation (collectively, the “**Grantors**”) and Credit Suisse AG, as administrative agent and collateral agent (in such capacity, the “**Administrative Agent**”), for the lenders from time to time party to the First Lien Credit Agreement, dated as of March 30, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among Road Infrastructure Investment, LLC, a Delaware limited liability company (the “**Borrower**”), Road Infrastructure Investment Midco, LLC, a Delaware limited liability company (“**Holdings**”), the lenders, the Administrative Agent and the other parties thereto. Capitalized terms used herein without definition are used as defined in the Credit Agreement and the Guarantee and Collateral Agreement (as hereinafter defined), as applicable.

WHEREAS, pursuant to the First Lien Guarantee and Collateral Agreement, dated as of March 30, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Guarantee and Collateral Agreement**”), made by the Borrower, Holdings, as a Guarantor, and the subsidiary guarantors party thereto in favor of the Administrative Agent, a security interest was granted by the Borrower and the subsidiary guarantors to the Administrative Agent in the Borrower’s and the subsidiary guarantors’ Intellectual Property, including their Trademarks;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 30, 2012 (the “**Trademark Security Agreement**”) by the Grantors in favor of the Administrative Agent, the Grantors, by reference to the Guarantee and Collateral Agreement, confirmed their pledge and grant of a security interest to the Administrative Agent specifically in their Trademarks, including, without limitation, the Trademarks set forth on Schedule A hereto (the “**Released Trademarks**”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 4, 2012 on Reel 4766, Frame 0985; and

WHEREAS, the Administrative Agent has agreed to release its security interest in the Released Trademarks;


NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Guarantee and Collateral Agreement, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby irrevocably terminate and release its security interest in the Trademarks (including, without limitation, the Released Trademarks) pledged and granted to the Administrative Agent pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, together with all of the goodwill associated therewith and reassigns and transfers any right, title and interest that the Administrative Agent may have in the Released Trademarks to the applicable Grantor, effective as of the date set forth above. Any and all right, title or interest of the Administrative Agent in the Released Trademarks, including without limitation the goodwill of the business connected with the use of, and symbolized by, the Released Trademarks and any and all causes of action which may exist by reason of infringement of the Released Trademarks, shall hereby cease and become void. This Release shall be binding upon the Administrative Agent’s legal representatives, assigns and successors.


