TRADEMARK ASSIGNMENT AGREEMENT

Preamble

This Trademark Assignment Agreement (the "AGREEMENT"), is made and entered into by and between MKTG, Inc., a Delaware corporation ("MKTG") and The Procter & Gamble Company, an Ohio corporation ("P&G").

P&G and MKTG have entered into that certain Asset Purchase Agreement, dated on or near this AGREEMENT, which provides, among other things, for the sale and assignment by P&G to MKTG of certain assets. The assets assigned include all of P&G's right, title and interest in and to those trademarks listed on the attached Schedule A ("MARKS").

Agreement

- 1. P&G hereby assigns, transfers, conveys and delivers to MKTG and MKTG's successors and assigns, and MKTG hereby accepts from P&G, all of P&G's right, title and interest in and to the MARKS, subject to existing licenses, the goodwill of the businesses symbolized thereby, and all benefits, privileges, causes of action, and remedies relating thereto throughout the world, including, without limitation, exclusive rights to: (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof, and (c) grant licenses or other interests therein.
- 2. P&G hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record MKTG as the owner of the MARKS, and to issue any and all MARKS to MKTG, as assignee of P&G's entire right, title and interest in, to, and under the same. MKTG will have the right to record this AGREEMENT with all applicable government authorities and registrars so as to perfect its ownership of the MARKS.
- 3. P&G will provide MKTG, its successors, assigns or other legal representatives, reasonable cooperation and assistance at MKTG's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation as may be reasonably required) as are requested by MKTG to register or perfect the rights assigned herein, including the preparation, execution, and delivery of all documentation which may be reasonably necessary to further document and record the assignment of the MARKS made herein.
- 4. This AGREEMENT will be governed by, and construed in accordance with, the laws of the State of Ohio without reference to such state's principles of conflicts of law. This AGREEMENT may not be supplemented, altered, or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this AGREEMENT will not waive any of its rights under such terms or provisions. This AGREEMENT will bind and inure to the benefit of the respective parties and their respective assigns, transferees and successors.
