**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of May 16, 2014, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as Administrative Agent (the “**Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Credit Agreement, dated as of April 30, 2013 (as the same may be amended, restated, supplemented and/or modified from time to time, the “Credit Agreement”), by and among ABILITY Network Inc., a Delaware corporation (the “Borrower”), the other Loan Parties, the Lenders and the L/C Issuers from time to time party thereto and General Electric Capital Corporation, as Administrative Agent, Swing Line Lender and Collateral Agent, the Lenders and the L/C Issuers have severally agreed to make extensions of credit to the Borrower.

WHEREAS, each Grantor (other than the Borrower) has agreed, pursuant to a Security Agreement dated April 30, 2013, in favor of Agent (and such agreement may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), to guarantee the Guaranteed Obligations (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, Security Agreement and pursuant to that certain agreement described on Annex I attached hereto (the “**Trademark Security Agreement**”), the Grantors granted security interests in certain intellectual property owned by the Grantors, including without limitation the trademarks listed on Annex I attached hereto (collectively, the “**Trademarks**”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the “**USPTO**”) on the date and on the reel and frame set forth on Annex I hereto;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby **releases, relinquishes, terminates and discharges**, without representation, recourse or warranty whatsoever, any and all of its security interest in the intellectual property of the Grantors, including the Trademarks, and all of the goodwill of the businesses connected with the use of, and symbolized by the Trademarks, whether granted pursuant to the Credit Agreement or the Trademark Security Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademarks to the Grantors.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
