**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of May 30, 2014 in favor of PlayCore Wisconsin, Inc., PlayCore IP Sub, Inc., Ultra Play Systems, Inc., Everlast Climbing Industries, Inc., Robertson Industries, Inc., and GT Grandstands, Inc. (each a "Grantor" and collectively, "Grantors") by BNP Paribas, as administrative agent for the Lenders (in such capacity, "Secured Party").

**WHEREAS**, PlayCore Wisconsin, Inc. ("Company") entered into that certain Credit Agreement dated as of June 30, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") with the financial institutions named therein (collectively, together with their respective successors and assigns party to the Credit Agreement from time to time, the "Lenders") and Secured Party;

**WHEREAS**, Company, from time to time, entered or may have entered into one or more swap agreements (collectively, the "Lender Hedge Agreements") with one or more persons that were Lenders or affiliates of Lenders at the time such Lender Hedge Agreements were entered into (in such capacity, collectively, "Hedge Agreement Counterparties");

**WHEREAS**, Grantors entered into that certain Subsidiary Guaranty dated as of June 30, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty") in favor of Secured Party for the benefit of Lenders and any Hedge Agreement Counterparties;

**WHEREAS**, pursuant to that certain Security Agreement dated as of June 30, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Grantors, Secured Party and the other grantors named therein, Grantors created in favor of Secured Party a security interest in, and Secured Party has become a secured creditor with respect to, the Trademark Collateral (as defined below);

**WHEREAS**, pursuant to the Security Agreement, Grantors, Secured Party and the other grantors named therein entered into that certain Grant of Trademark Security Interest dated as of June 30, 2011 (the "Trademark Security Agreement"), whereby each Grantor granted to Secured Party a security interest in all of such Grantor's right, title and interest in and to the following, in each case whether then or thereafter existing or in which such Grantor then had or thereafter acquired an interest and wherever the same may be located (the "Trademark Collateral");

- (a) all rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade

styles and/or other source and/or business identifiers and applications pertaining thereto, owned by such Grantor, or hereafter adopted and used, in its business (including, without limitation, the trademarks set forth on Schedule A annexed hereto) (collectively, the "Trademarks"), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof and in foreign countries (except for any applications for Trademarks filed pursuant to 15 U.S.C. §1051(b)) (including, without limitation, the registrations and applications set forth on Schedule A annexed hereto), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries, and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith; and

- (b) all proceeds of the foregoing Trademark Collateral. For the purposes of this Release and the Trademark Security Agreement, the term "proceeds" shall have the meaning given to such term in the Uniform Commercial Code, as it exists on the date hereof or as it may hereafter be amended, in the State of New York;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 29, 2011 at Reel 4730, Frame 0282; and

**WHEREAS**, Grantors have paid all of their outstanding indebtedness and all other Obligations (as defined in the Credit Agreement) to Secured Party and the Secured Party has agreed to release its security interest in the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby, on behalf of itself and the Lenders (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all liens and security interests it has in, to and under the Trademark Collateral, (iii) re-assigns to Grantors any right, title and interest they may have in, to and under the Trademark Collateral, and (iv) authorizes and requests the United States Patent and Trademark Office, and any other location where the security interest was filed, to note and record the existence of such release hereby given.

Secured Party shall, at Grantors' expense, take all further actions, and provide to each Grantor, its successors, assigns or other legal representatives, all such necessary cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor to more fully and effectively effectuate the purposes of this Release.


This Release shall be governed by and construed in accordance with the laws of the State of New York.


