RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, by that certain Intellectual Property Security Agreement dated July 30, 2013 (“Security Agreement”), originally recorded in the Trademark Assignment database of the United States Patent and Trademark Office on July 31, 2013 at Reel/Frame 005081/0697, and in the Patent Assignment database of the United States Patent and Trademark Office on July 31, 2013 at Reel/Frame 030936/0291, SPECIALTY FERTILIZER PRODUCTS, LLC, an Ohio limited liability company with an address at 11550 Ash Street, Suite 220, Leawood, Kansas 66211 (“Grantor”), granted to UMB BANK, N.A., a national banking association with an address at 1010 Grand Boulevard, Kansas City, Missouri 64106 (together with its successors and assigns, “Releasor”), a continuing security interest in, and a mortgage upon, all of Grantor’s right, title and interest in, to and under certain “Collateral” (as defined in Section 2(a), including subsections (i) – (viii) thereof, of the Security Agreement), including without limitation the Collateral identified in Schedule A (Trademarks, Service Marks and Tradenames), Schedule B-1 (Patents and Patent Applications), Schedule C (Copyrights), and Schedule D (Applications for Copyright Registrations), all attached hereto and incorporated herein by reference;

WHEREAS, Grantor and Releasor are parties to that certain Payoff Letter dated June 27, 2014 (the “Payoff Letter”), which letter governs the satisfaction of certain obligations between the parties thereto;

WHEREAS, conditioned upon Grantor’s delivery of the Payoff Deliverables (as defined in the Payoff Letter) and satisfaction of the Specified Obligations (as defined in the Payoff Letter) (the time of such delivery and satisfaction, the “Effective Time”), Releasor agrees to release and discharge Grantor from the terms and conditions set forth in the Security Agreement, and

WHEREAS, the parties wish to record with the United States Patent and Trademark Office and with any other office in which the Security Agreement was recorded, the release of the security interest provided in the Security Agreement against the Collateral upon the Effective Time.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, and upon the Effective Time and with no further action by or on behalf of the parties, (i) Releasor releases and discharges (in each case without recourse and without representation or warranty of any kind or nature, express or implied) the security interest, liens, and all other rights, if any, it may have in the Collateral granted to it by Grantor pursuant to the Security Agreement, and (ii) Releasor agrees and acknowledges that the Security Agreement shall be terminated. This Release of Security Interest in Intellectual Property shall be recorded in the Trademark Assignment database and in the Patent Assignment database of the United States Patent and Trademark Office, and with any other office in which the Security Agreement was recorded. Releasor agrees to take such further actions as may be reasonably requested by Grantor in order to give effect to the matters described herein, provided that such actions shall be taken at the Grantor’s sole cost and expense.
