**Grant of Security Interest
in United States Patents and Trademarks**

July 8, 2014

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, and in connection with the Amendment and Restatement Agreement, dated as of July 8, 2014 (the "Amendment and Restatement Agreement"), by and among VeriFone, Inc., a Delaware corporation (the "Borrower"), VeriFone Intermediate Holdings, Inc., a Delaware corporation ("Holdings"), the other Loan Parties party thereto, JPMorgan Chase Bank, N.A. ("JPMCB") as Administrative Agent and Collateral Agent and the other lenders party thereto, in connection with the Credit Agreement, dated as of December 28, 2011 (as amended, restated, amended and restated, modified or otherwise supplemented through the date hereof and as amended and restated by the Amendment and Restatement Agreement, the "Credit Agreement"), by and among Holdings, the Borrower, the lenders from time to time party thereto, JPMCB, as Administrative Agent and Collateral Agent, the lenders from time to time party thereto and the other parties from time to time party thereto, each of the Borrower, VeriFone Media, LLC, a Delaware limited liability company, Global Bay Mobile Technologies Inc., a Delaware corporation, and Hypercom Corporation, a Delaware corporation (each a "Grantor" and, collectively, the "Grantors"), hereby grants to JPMCB, as Collateral Agent, (the "Grantee"), with offices at 10 S. Dearborn St., 7th Floor, Chicago, IL 60603, a security interest in all of its right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Patent and Trademark Collateral"), whether presently existing or hereafter arising or acquired:

- (i) each United States patent and patent application, including each Patent and Patent Application referred to on Schedule A hereto;
- (ii) each Patent License, including each Patent License listed on Schedule A hereto;
- (iii) each United States trademark, trademark registration and trademark application, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application, including each Trademark, Trademark Registration and Trademark Application referred to in Schedule B hereto, excluding in all cases any United States intent-to-use trademark applications until and unless a Statement of Use or an Amendment to Allege Use has been filed and accepted by the United States Patent and Trademark Office with respect to such intent-to-use application;
- (iv) each Trademark License, whether registered or not, including each Trademark License referred to in Schedule B hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (v) all products and proceeds of the foregoing, including any claim by the Grantors against third parties for past, present or future infringement of any Patent, or past, present or future infringement or dilution of any Trademark or Trademark

registration, including any Patent or Trademark listed on Schedule A or B hereto, or under any Patent or Trademark licensed under any Patent License or Trademark License, including any such License listed on Schedule A or B hereto, or for injury to the goodwill associated with any Trademark, Trademark registration or Trademark License.




