TRADEMARK ASSIGNMENT

NOW, THEREFORE, the Assignor does hereby sell, assign, transfer and set over unto the Secured Party, its successors and assigns, as collateral security to secure the Obligations under and as defined in the Security Agreement, the entire and exclusive right, title and interest in and to: (i) the Marks, (ii) the Registrations, (iii) the goodwill of the business symbolized by and associated with the Marks and the Registrations thereof, and (iv) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringement or dilution of or damage or injury to the Marks or the Registrations thereof or such associated goodwill. The Assignor further agrees to execute and have executed all documents, instruments and papers and to perform all acts, without any further consideration but at the cost and expense of the Secured Party, as deemed reasonably necessary by the Secured Party to perfect in the Secured Party the foregoing rights, title and interests, including the execution of any related domestic or foreign application documents.


