THIRD LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

This THIRD LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*IP Security Agreement*”) dated as of January 31, 2014, is made by the Persons listed on the signature pages hereof (collectively, the “*Foreign Grantors*”) in favor of BANK OF AMERICA, N.A., as Foreign Administrative Agent (the “*Foreign Administrative Agent*”) for the Foreign Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, Chemtura Corporation, a Delaware corporation (the “*Company*”) and the Subsidiary Borrowers referred to therein (together with the Company, the “*Borrowers*”) have entered into a Senior Secured Revolving Facilities Credit Agreement dated as of November 10, 2010 (as amended and restated on December 4, 2013 and as further amended, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”), with Bank of America, N.A., as Foreign Administrative Agent, and the Lender Parties and the other agents party thereto. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement.

WHEREAS, as a condition precedent to the making of Foreign Revolving Credit Advances and the issuance of Foreign Letters of Credit by the Foreign Lender Parties under the Credit Agreement and the entry into Secured Cash Management Agreements by the Foreign Cash Management Banks from time to time, each Foreign Grantor has executed and delivered that certain Security Agreement dated as of November 10, 2010 made by the Foreign Grantors to the Foreign Administrative Agent (as amended and restated on December 4, 2013 and as further amended, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”).

WHEREAS, under the terms of the Security Agreement, the Foreign Grantors have granted to the Foreign Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Foreign Grantors, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Foreign Grantor agrees as follows:

SECTION 1. Grant of Security. Each Foreign Grantor hereby grants to the Foreign Administrative Agent for the ratable benefit of the Foreign Secured Parties a security interest in all of such Foreign Grantor’s right, title and interest in and to the following (the “*Collateral*”):

- (i) all patents and patent applications set forth in Schedule A hereto (the “*Patents*”);
- (ii) all trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in any United States intent-to-use trademark application for registration of a trademark filed pursuant to

Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a “Statement of Use” pursuant to Section 1(d) of the Lanham Act or an “Amendment to Allege Use” pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability or result in the voiding of such application or any registration that issues from such application under applicable federal law), together, in each case, with the goodwill symbolized thereby (the “*Trademarks*”);

(iii) all copyright registrations and applications set forth in Schedule C hereto (the “*Copyrights*”);

(iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions and all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Foreign Grantor accruing thereunder or pertaining thereto;

(v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to any of the foregoing.

SECTION 2. Security for Obligations. The grant of a security interest in the Collateral by each Foreign Grantor under this IP Security Agreement secures the payment of all Foreign Obligations of each Foreign Loan Party or Subsidiary of a Foreign Loan Party now or hereafter existing under or in respect of the Loan Documents (including, without limitation, the Foreign Secured Cash Management Agreements), whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise. Without limiting the generality of the foregoing, this IP Security Agreement secures, as to each Foreign Grantor, the payment of all amounts that constitute part of the Secured Obligations and that would be owed by any Foreign Loan Party or Subsidiary of a Foreign Loan Party to any Foreign Secured Party under the Foreign Loan Documents but for the fact that such Secured Obligations are unenforceable or not allowable due to the existence of a bankruptcy, reorganization or similar proceeding involving a Foreign Loan Party or Subsidiary of a Foreign Loan Party.

SECTION 3. Recordation. Each Foreign Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Agreement.

SECTION 4. Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 5. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. Each Foreign Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Foreign Administrative Agent with respect to the Collateral are more fully set forth in the Security Agreement. In the event of a conflict between the provisions of this IP Security Agreement and the provisions of the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 6. Governing Law. This IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 7. Intercreditor Agreement. **Reference is made to the Intercreditor Agreement. Notwithstanding any other provision contained herein, this IP Security Agreement, the Liens created hereby and the rights, remedies, duties and obligations provided for herein are subject in all respects to the provisions of the Intercreditor Agreement and, to the extent provided therein, the applicable Senior Secured Obligations Security Documents (as defined in the Intercreditor Agreement). In the event of any conflict or inconsistency between the provisions of this IP Security Agreement and the Intercreditor Agreement, the provisions of the Intercreditor Agreement shall control.**
