**FIRST AMENDED AND RESTATED  
GRANT OF SECURITY INTEREST IN  
MARKS AND PATENTS  
(FIRST LIEN)**

**Dated as of June 30, 2014**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Solo Cup Operating Corporation, a Delaware corporation (the "Grantor") with principal offices at 150 South Saunders Road, Suite 150, Lake Forest, Illinois 60045, hereby grants to Wilmington Trust (London) Limited, as First Lien Collateral Agent, with principal offices at Third Floor, 1 King's Arms Yard, London EC2R 7AI, United Kingdom (the "Grantee"), a first priority security interest in (i) all of the Grantor's right, title and interest in and to the trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all of the Grantor's right, title and interest in and to patents (the "Patents") set forth on Schedule B attached hereto, in each case together with (iii) all Proceeds (as such term is defined in the Third Amended and Restated First Lien Security Agreement referred to below) of the Marks and Patents, (iv) the goodwill of the businesses symbolized by the Marks and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or Patents or unfair competition regarding the same.


THIS GRANT is made to secure the full and prompt performance and payment of all the Grantor's Guarantor First Lien Secured Obligations, as such term is defined in the Third Amended and Restated First Lien Security Agreement between the Grantor, the other grantors from time to time party thereto and the Grantee, dated as of June 30, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Security Agreement"). Upon the occurrence of the First Lien Termination Date (as defined in the First Lien Security Agreement), the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks and Patents acquired under this Grant of Security Interests to the Grantor.

THIS GRANT has been granted in conjunction with the security interests granted to the Grantee under the First Lien Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are more fully set forth in the First Lien Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interests are deemed to conflict with the First Lien Security Agreement, the provisions of the First Lien Security Agreement shall govern.
