TRADEMARK ASSIGNMENT

For countries where predecessors of the Assignor are still registered as holder of the respective Trademark Rights and a direct assignment of those rights is possible Assignor will cause those predecessors to sign all necessary documents and provide all necessary statements in order to effect such direct assignment. Otherwise, the Assignor will make sure that the registered holder of the respective Trademark Rights will sign all necessary documents and provide all
