NOW THEREFORE, in consideration of the covenants and agreements contained in the Asset Purchase Agreement and herein and such other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto, each of the Assignors confirm that they have assigned, transferred and sold, and, to the extent that they have not assigned, transferred and sold, hereby assign, transfer, and sell to the Assignee, its successors and assigns, the whole right, title, and interest, in and to their respective trademark(s) listed amongst the Trademarks, together with the goodwill associated therewith, and any and all rights of action accruing to each Assignor as owner of their respective trademark(s) listed amongst the Trademarks, including actions arising from prior infringement or other unauthorized use of the trademark, and any and all rights as a party in any opposition or similar proceedings, the same to be held and enjoyed as fully and exclusively as the same would have been held and enjoyed by each of the Assignors had this sale, assignment, transfer and setting over not been made.

Each of the Assignors hereby undertakes at any time upon reasonable request to execute such documents and take such further actions as may be necessary to evidence the assignment of the Trademarks to the Assignee, and to enable the Assignee to obtain and maintain the applications and registrations for the Trademarks, all without further consideration.

The Assignors do hereby authorize any official whose duty it is to grant trademarks or related registrations, to issue registrations for any pending or yet to be filed applications for said Trademarks to the Assignee, and to the Assignee's successors, assigns, nominees or other legal representatives.

The Assignors, on behalf of themselves and their successors, assigns, nominees or other legal representatives, do hereby authorize said Assignee, its successors, assigns, nominees or other legal representatives, including its Trademark Agents to amend the present assignment document to insert or correct the filing date, serial number, registration number or other identifying information of the Owned Intellectual Property as may be needed to record same.

This Assignment may be executed in as many counterparts as may be necessary, each of which so executed shall be deemed to be an original and each signed copy sent by facsimile or other means of electronic transmission producing a printed copy shall be deemed to be an original, and such counterparts together shall constitute one and the same document and notwithstanding the date of execution shall be deemed to be effective as of the date set forth above.
