RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is given as of July 25, 2014 to APPLE & EVE, LLC, a Delaware limited liability company and US JUICE PARTNERS, LLC, a Delaware limited liability company (collectively, the "Grantor"), by GARRISON LOAN AGENCY SERVICES LLC, in its capacity as agent (in such capacity, the "Agent"), with respect to each of the trademarks identified on Exhibit A to this Release (the "Released Trademarks").

WHEREAS, the Grantor and Agent entered into that Trademark Security Agreement, dated as of December 11, 2012, and recorded in the United States Patent and Trademark Office on December 13, 2012 at Reel/Frame No. 004919/0054, pursuant to which the Grantor granted to Agent a security interest in certain of the Released Trademarks; and

WHEREAS, Agent desires to release its security interest in and liens upon the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby states as follows:

1. Release. Agent hereby (i) releases its lien on and security interest in the Released Trademarks (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Trademarks and (iii) reassigns any and all interest it may have in the Released Trademarks to the Grantor, in each case without representation or warranty by, or recourse to, Agent.

2. Recordation of Trademark Release. This Release has been executed and delivered by the Agent for the purpose of recording with the United States Patent and Trademark Office and the Canadian Intellectual Property Office.

3. Governing Law. This Release shall be construed in accordance with the laws of the State of New York without giving effect to any conflict of law principles (but giving effect to laws relating to national banks).


