**TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS (this “**Termination and Release**”) dated July 31, 2014, from The Royal Bank of Scotland plc, as Security Trustee (the “**Security Trustee**”) for the Secured Parties (as defined in the Facilities Agreement referred to below), in favor of ALM Media Holdings, Inc. (f/k/a Incisive Media U.S. Holdings, Inc.), ALM Media, LLC (f/k/a Incisive Media, LLC) and ALM Media Properties, LLC (f/k/a Incisive Media US Properties, LLC) (collectively, the “**IP Grantors**”).

**WHEREAS**, Incisive Media U.S. Holdings, Inc., renamed ALM Media U.S. Holdings, Inc., a company organized under the laws of the state of Delaware, has entered into a Facilities Agreement, dated August 14, 2007, as amended and restated as of September 30, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Facilities Agreement**”), with Allies Holdings LLC and The Royal Bank of Scotland plc, as Original Lender, Arranger, Facility Agent, Issuing Bank and Security Trustee on behalf of the Secured Parties (defined therein), among others.

**WHEREAS**, the IP Grantors and the Security Trustee, among others, entered into a Security and Pledge Agreement dated as of August 16, 2007 as amended and restated as of September 30, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”).

**WHEREAS**, under the terms of the Security Agreement, IP Grantors granted a security interest in, among other property, certain intellectual property of the IP Grantors to the Security Trustee for the rateable benefit of the Secured Parties, and agreed as a condition thereof to execute an IP Security Agreement (defined below) covering such intellectual property for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

**WHEREAS**, IP Grantors and the Security Trustee entered into that certain Intellectual Property Security Agreement dated as of September 30, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**IP Security Agreement**”);

**WHEREAS**, the IP Security Agreement was recorded in the U.S. Patent and Trademark Office on October 21, 2009 at Reel/Frame No. 4082/0361;

**WHEREAS**, the IP Security Agreement was recorded in the U.S. Copyright Office on April 21, 2014 (recordation number forthcoming); and

**WHEREAS**, the Security Trustee now desires to terminate and release the entirety of its security interest in the IP Collateral.

**NOW, THEREFORE**, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the IP Collateral pursuant to the Security

Agreement and IP Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Security Trustee hereby states as follows:

1. **Definitions.** Capitalized terms used in this Termination and Release but not defined herein shall have the respective meanings ascribed to them in the IP Security Agreement.

2. **Release of Security Interest.** The Security Trustee hereby terminates, releases and discharges in full its entire security interest in and to all of each IP Grantor's right, title and interest in and to the following (the "**IP Collateral**"):

2.1 all United States, international and foreign patents, patent applications and patent licenses owned by such IP Grantors, including such patents, patent applications and licenses set forth in Schedule A hereto, together with all reissues, divisions, continuations, continuations-in-part, extensions and re-examinations thereof, and all rights therein provided by international treaties or conventions (the "**Patents**");

2.2 all United States and foreign trademark and service mark registrations, applications and licenses owned by such IP Grantors, including the registrations, applications and licenses set forth in Schedule B hereto (the "**Trademarks**");

2.3 all copyrights, United States and foreign copyright registrations and applications and copyright licenses owned by such IP Grantors, including the registrations, applications and licenses set forth in Schedule C hereto (the "**Copyrights**");

2.4 any and all claims for damages for past, present and future infringement, misappropriation or breach with respect to the Patents, Trademarks and Copyrights, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

2.5 any and all proceeds of the foregoing.

3. **Recordation.** The Security Trustee authorizes and requests that the Register of Copyrights, the Commissioner of Patents and Trademarks and any other applicable government officer record this Termination and Release.

5. **Further Assurances.** The Security Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.

7. **Governing Law.** This Termination and Release, the relationship between the Security Trustee and each IP Grantor and any claim or dispute (whether sounding in contract, tort, statute or otherwise) relating to this Termination and Release or that relationship shall be governed by and construed in accordance with the law of the State of New York including section 5-1401 of the New York General Obligation Law but excluding any other conflict of law rules that would lead to the application of the law of another jurisdiction. If the law of a jurisdiction other than



New York is, under section 1-105(2) of the UCC, mandatorily applicable to the perfection, priority or enforcement of any security interest released under this Termination and Release, that other law shall apply solely to the matters of perfection, priority or enforcement to which it is mandatorily applicable.
