**FIRST AMENDMENT TO  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT** (the "Amendment") is made as of the 31st day of July, 2014 by and between **INMUSIC BRANDS, INC.**, a Florida corporation with its principal place of business at 200 Scenic View Drive, Suite 201, Cumberland, Rhode Island 02864 ("inMusic Brands") and **BANK OF AMERICA, N.A.**, a national banking association with an office at 100 Westminster Street, Providence, Rhode Island 02903 (the "Bank"), in consideration of the mutual covenants herein contained and benefits to be derived herefrom.

**RECITALS**

A. inMusic Brands executed and delivered that certain Intellectual Property Security Agreement dated as of September 28, 2012 (the "IP Agreement") in favor of the Bank and recorded with the United States Patent and Trademark Office on October 18, 2012 at Reel 4883, Frame 0383, pursuant to which inMusic Brands pledged, assigned and granted a security interest in favor of the Bank in the Intellectual Property Collateral (as defined therein); and

B. inMusic Brands has acquired additional Intellectual Property Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Intellectual Property Collateral in favor of the Bank.

Accordingly, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. Amendment to IP Agreement.
  - (a) Exhibit B to the IP Agreement is hereby deleted in its entirety and Exhibit "B" annexed hereto is inserted in its place.
  - (b) Exhibit C to the IP Agreement is hereby deleted in its entirety and Exhibit "C" annexed hereto is inserted in its place.
3. Miscellaneous:
  - (a) inMusic Brands authorizes and requests that the Register of Copyrights and the Commissioner of Patents and Trademarks record this Amendment or evidence of same.
  - (b) Except as expressly modified herein, all terms and conditions of the IP Agreement remain in full force and effect. inMusic Brands hereby ratifies, confirms and reaffirms the grant of a security interest and all of the representations, warranties and covenants contained in the IP Agreement.


- (c) This Amendment covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
- (d) This Amendment may be executed in multiple identical counterparts (including by facsimile or e-mail transmission of an Adobe portable document file format (also known as a PDF file)), each of which when duly executed will be deemed an original, and all of which will be construed together as one agreement.


