**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby releases, without any representation, recourse or undertaking by the Grantee, any and all liens on and security interests in the Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on <u>Schedule A</u> hereto, granted pursuant to the Trademark Security Agreement and hereby terminates the Trademark Security Agreement.

Upon the request of Grantor, Grantee further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest; <u>provided that</u> all such documents are to be prepared by counsel to the Grantor and the cost and expense of such documents shall be borne solely by Grantor.
