CERTIFICATE OF SALE

WHEREAS, the following proceedings were had on July 25, 2014 at approximately 3:00 p.m. in Room 102, Maricopa County Superior Court, 18380 N. 40<sup>th</sup> St., Phoenix AZ 85032 involving Greg Good ("Good"), Plaintiff in Maricopa County Cause No. CV2010-050768 ("the Action"), and Farmasea Health, L.L.C. ("Farmasea") and Scott Kennedy ("Kennedy"), who are Defendants in the Action:

1. Pursuant to a Settlement Agreement ("Settlement") entered into between Good, on the one hand, and Farmasea and Kennedy, on the other hand, on or about April 19, 2011, Good became the Secured Party under a certain Trademark Security Agreement dated April 19, 2011 and under an Inventory Security Agreement dated April 19, 2011 ("the Agreements"). In doing so, he acquired a security interest in certain collateral described in the Agreements.

2. As part of the Settlement, Good also received from Farmasea and Kennedy a Promissory Note ("Note") dated April 19, 2011 in the face amount of \$350,000.00, which was payable in full on April 19, 2014. Good is the current holder of the Note and holds the Secured Party's interests under the Agreements.

3. Farmasea and Kennedy defaulted on the Note and Agreements by failing to make the payments required. No portion of the Note balance has been received by Good, and the Note is accruing interest according to its terms.

4. Following the default, Good, through counsel undersigned, issued a Notice of Sale dated May 16, 2014 in which he scheduled a sale under A.R.S. §§ 47-9610 and 47-9611 and under § 8(A) and § 5, respectively, of the Agreements, which sale was to take place on July 25, 2014 beginning at 2 p.m. at the Maricopa County Superior Court at the address shown above. The items to be sold were described with particularity in the Notice of Sale, and consisted mainly of certain trademarks, domain names and bales of sea weed. All interests of Farmasea and Kennedy in the trademarks, domain names and bales of sea weed was to be sold to the highest bidder by public auction.

5. The Notice of Sale was duly advertised on repeat occasions in a local business journal of general circulation in advance of the Sale. In addition, Good circulated approximately 41 copies of the Notice of Sale to professional acquaintances who might have had interest in purchasing the items to be sold. Farmasea and Kennedy were both given advance notice of the Sale, having received such notice by certified mail/return receipt requested on May 17, 2014. Neither appeared at the Sale, either in person or through counsel.

6. Immediately following a regularly scheduled hearing in the Action which commenced at 2:00 on July 25, 2014, undersigned counsel conducted a UCC foreclosure sale of the trademarks, domain names and bales of seaweed inventory pursuant to the May 16, 2014 Notice of Sale. The Sale began at approximately 3 p.m. and was recorded in its entirety on the Courtroom's live audio system.

**Bill of Sale**

7. The reading of the Notice of Sale was dispensed with, and the items to be sold were described in general terms. All items were then put up for sale in a single grouping. The specific items put up for sale are listed with particularity on Exhibit "A" and Exhibit "B" attached hereto.

8. Bids were solicited from persons present. Greg Good entered a bid of \$150,000.00 as a credit bid against the amounts he is owed under the Note. Good's bid was the only bid received, and it was declared to be the high bid at the Sale.

9. All items for sale were declared **SOLD** to Greg Good for \$150,000.00.

10. As a consequence of the foregoing proceedings, Greg Good is now the legal owner of all property described on Exhibits "A" and "B" attached. Pursuant to the terms of the Notice of Sale, Good acquired this property as-is, where-is, with no warranties either express or implied, including but not limited to any warranties of merchantability and fitness for a particular purpose, and also subject to any senior liens which may be of record.
