## **TRADEMARK ASSIGNMENT**

**THIS TRADEMARK ASSIGNMENT** (this "Assignment") is made and entered into as of July 28, 2014, ("Effective Date") by and between Lifestyle Brands Corporation, a Nova Scotia unlimited liability corporation, with its principal office at 850 Englewood Parkway, Suite C200, Englewood, Colorado 80110 ("Assignor"), and ABG Collective LLC, a Delaware limited liability company, with its principal office at 100 West 33<sup>rd</sup> Street, New York, New York 10001 ("Assignee").

**WHEREAS**, Lifestyle Brands Corporation and ABG Collective LLC are parties to that certain Asset Purchase Agreement dated as of July 28, 2014 (the "Agreement"), providing for the execution and delivery of this Assignment;

**WHEREAS**, pursuant to the Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, the trademarks and service marks set forth on Schedules A, B, C and D attached hereto and incorporated by reference herein, including the United States registrations set forth on Schedule A attached hereto, the United States applications for registration set forth on Schedule B attached hereto, the foreign registrations set forth on Schedule C attached hereto and the foreign applications for registration set forth on Schedule D attached hereto (collectively, the "Marks"); and

**WHEREAS**, Assignee is a successor to that part of Assignor's business to which the Marks pertain, and that business is ongoing and existing.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee (a) its entire right, title and interest in and to the Marks, for the United States and for all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, and all goodwill of the business connected with the use thereof and symbolized thereby, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with (b) any past, present or future claims or causes of actions arising out of or related to any infringement, dilution, misappropriation or other violation of any of the foregoing, and all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby authorizes and requests the Commissioner for Trademarks, and the corresponding entities or agencies in any applicable foreign jurisdictions, to record Assignee as the assignee and owner of the Marks.

After the Effective Date, Assignor shall, from time to time, as and when requested by Assignee, without further consideration, execute and deliver such further instruments of conveyance and transfer as may be reasonably requested by Assignee to effect or evidence or record the transfer of any of the Marks.

This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware (regardless of the laws that might otherwise govern under applicable Delaware principles of conflicts of law) as to all matters.


