**FIRST AMENDMENT TO  
AMENDED AND RESTATED TRADEMARK AND PATENT SECURITY AGREEMENT**

**THIS FIRST AMENDMENT TO AMENDED AND RESTATED TRADEMARK AND PATENT SECURITY AGREEMENT** (this "Amendment"), dated as of April 21, 2014, is made and entered into by DEROYAL INDUSTRIES, INC., a Tennessee corporation (the "Grantor"), in favor of REGIONS BANK, an Alabama banking corporation ("Regions Bank"), as administrative agent for itself, the Lenders and the Issuing Bank under the Credit Agreement (in such capacity, the "Administrative Agent").

**RECITALS:**

1. Grantor and Administrative Agent entered into that certain Amended and Restated Trademark and Patent Security Agreement dated as of December 27, 2007 (as amended, restated, supplemented, extended, renewed, replaced or otherwise modified from time to time, the "Trademark and Patent Security Agreement"; capitalized terms used by not defined herein have the same meaning as in the Trademark and Patent Security Agreement), in connection with that certain Amended and Restated Credit Agreement dated as of December 27, 2007 by and among Grantor, certain Guarantors, certain Lenders, the Arranger, the Administrative Agent and Regions Bank, as Issuing Bank (as the same heretofore may have been or hereafter may be amended, restated, supplemented, extended, renewed, replaced or otherwise modified from time to time, the "Credit Agreement").

2. The parties hereto desire to amend the Trademark and Patent Security Agreement in certain respects, as more particularly hereinafter set forth, to, among other things, update the Collateral.

3. It is a condition precedent to the obligation of Lender to make the Loans (as defined in the Credit Agreement) to Borrower under the Credit Agreement that Grantor execute this Amendment.

4. The parties hereto desire to execute and deliver this Amendment in order to induce Lender to make the Loans.

**AGREEMENTS:**

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of all of which are hereby acknowledged, the parties hereto agree as follows:

1. **Amendment of Schedules A and B.** Schedules A and B of the Trademark and Patent Security Agreement are hereby deleted and the Schedules A and B attached to this Amendment are hereby substituted therefor, such attached Schedules A and B being incorporated herein by reference in their entirety.

2. **Representations and Warranties of Grantor.** Grantor hereby agrees, represents and warrants that:

(a) This Amendment has been duly executed and delivered by a duly authorized representative of Grantor, and the Trademark and Patent Security Agreement, as modified and amended by this Amendment, constitutes a legal, valid and binding obligation of Grantor, and is enforceable against Grantor in accordance with its terms; and

(b) All of the representations and warranties of Grantor contained in the Credit Agreement and the Trademark and Patent Security Agreement are and continue to be true and correct in all material respects as of the date hereof as though made on and as of such date (except to the extent that such representations and warranties related solely to an earlier date, in which event such representations and warranties remain correct as of such date).

**3. Loan Document; Continuing Effectiveness of Trademark and Patent Security Agreement.**

(a) This Amendment shall be deemed to be a Loan Document for all purposes.

(b) Except to the extent amended or modified hereby, the Trademark and Patent Security Agreement and all terms, conditions and provisions thereof shall continue in full force and effect in all respects and shall be construed in accordance with the modifications of the Trademark and Patent Security Agreement effected hereby. Without limiting the generality of the foregoing, the Trademark and Patent Security Agreement and all of the Collateral described therein secure and shall continue to secure the payment of the Loans and all indebtedness and other obligations of the Grantor pursuant to the Trademark and Patent Security Agreement, in each case taking into account the modifications of the Trademark and Patent Security Agreement effected hereby.

**4. Counterparts.** This Amendment may be executed in multiple counterparts or copies, each of which shall be deemed an original hereof for all purposes. One or more counterparts or copies of this Amendment may be executed by one or more of the parties hereto, and some different counterparts or copies executed by one or more of the other parties. Each counterpart or copy hereof executed by any party hereto shall be binding upon the party executing same even though other parties may execute one or more different counterparts or copies, and all counterparts or copies hereof so executed shall constitute but one and the same agreement. Each party hereto, by execution of one or more counterparts or copies hereof, expressly authorizes and directs any other party hereto to detach the signature pages and any corresponding acknowledgment, attestation, witness or similar pages relating thereto from any such counterpart or copy hereof executed by the authorizing party and affix same to one or more other identical counterparts or copies hereof so that upon execution of multiple counterparts or copies hereof by all parties hereto, there shall be one or more counterparts or copies hereof to which is(are) attached signature pages containing signatures of all parties hereto and any corresponding acknowledgment, attestation, witness or similar pages relating thereto.

**5. Miscellaneous.**

(a) This Amendment shall be governed by and construed and enforced in accordance with the laws of the State of Tennessee, without reference to the conflicts or choice of law principles thereof.

(b) The headings in this Amendment and the usage herein of defined terms are for convenience of reference only, and shall not be construed as amplifying, limiting or otherwise affecting the substantive provisions hereof.

(c) All references herein to the preamble, the recitals or sections, paragraphs, subparagraphs, annexes or exhibits are to the preamble, recitals, sections, paragraphs, subparagraphs, annexes and exhibits of or to this Amendment unless otherwise specified. The

words "hereof", "herein" and "hereunder" and words of similar import, when used in this Amendment, refer to this Amendment as a whole and not to any particular provision of this Amendment.

(d) Any reference herein to any instrument, document or agreement, by whatever terminology used, shall be deemed to include any and all amendments, modifications, supplements, extensions, renewals, substitutions and/or replacements thereof as the context may require.

(e) When used herein, (1) the singular shall include the plural, and vice versa, and the use of the masculine, feminine or neuter gender shall include all other genders, as appropriate, (2) "include", "includes" and "including" shall be deemed to be followed by "without limitation" regardless of whether such words or words of like import in fact follow same, and (3) unless the context clearly indicates otherwise, the disjunctive "or" shall include the conjunctive "and".
