WHEREAS, pursuant to that certain Term Loan Agreement, dated as of March 21, 2013, by and among Albertson's LLC (the "Parent Borrower"), Albertson's Holdings LLC ("Holdings"), the Prior Agent and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Original Credit Agreement"), the Prior Agent and certain grantor parties identified on the signature page hereto (the "Grantors") entered into that (i) certain Security Agreement, dated as of March 21, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Original Security Agreement"), (ii) certain Trademark Security Agreement, dated as of March 21, 2013 (the "March Trademark Security Agreement") and (iii) certain Trademark Security Agreement, dated as of December 27, 2013 (the "December Trademark Security Agreement" and, collectively with the Original Credit Agreement and the March Trademark Security Agreement, the "Current Agreements"), pursuant to which the Grantors granted a security interest in and to certain collateral;
