After review of the record, the Court will enter the order that is requested by Mr. Good concerning the unauthorized transfer of the trademarks.

The settlement agreement, (which as Mr. Good through counsel states), was adopted by and entered as an order by Judge Miles, gives Mr. Good an interest in these various trademarks. It also provides that Farmasea Health, LLC and Mr. Kennedy shall not sell, assign, encumber or lease the marks to a third party except on a limited basis.

Greg Good is sworn and testifies for verification of the allegations in the application for order to show cause.

THE COURT FINDS that Mr. Good is entitled to the relief that he has sought in terms of enforcement of the settlement agreement. The Court agrees with counsel that the Court has inherent power to enforce its own order.

IT IS THEREFORE ORDERED that the ownership of title to the trademarks that are listed in Exhibit 2 to the application for order to show cause is revested in their owners prior to the assignment whether that be Farmasea Health, LLC or Scott Kennedy personally. The Court finds that the assignment of the trademarks was in violation of Judge Miles' order and that the assignments are void.

IT IS FURTHER ORDERED denying the request for the Court to conduct the sale of the trademarks and other collateral for the reasons stated on the record.

Plaintiff requests permission to hold the sale in the courtroom utilizing the electronic recording.

IT IS ORDERED granting said request. However, the Court does not consider the proceeding to be a Court proceeding. The Court is not giving it either the Court's judicial blessing or the Court's disapproval. The Court is simply going to exercise its authority to allow
