GRANT OF SECURITY INTEREST IN TRADEMARKS

September 19, 2014

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, CACHE, INC., a Delaware corporation, CACHE OF LAS VEGAS, INC., a Nevada corporation and CACHE OF VIRGINIA, INC., a Virginia corporation (collectively, the “Grantors” and each a “Grantor”), each with its principal office at 160 Mitchell Boulevard, San Rafael, California 94903, hereby grant to SALUS CAPITAL PARTNERS, LLC, a Delaware limited liability company with its principal office at 197 First Avenue, Suite 250, Needham, Massachusetts 02494 (the “Grantee”), a continuing security interest in and lien upon the following (except as such may be considered Excluded Property): (i) all of such Grantor’s right, title and interest in, to and under to the trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (the “Marks”), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors, as such term is defined in the Security Agreement by and among the Grantors and the Grantee, dated as of September 19, 2014 (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to them in the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
