FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

This Full Release and Reconveyance of Security Interests (“Release”) is granted by PNC BANK, NATIONAL ASSOCIATION, as term loan agent for the Lenders (as defined in the Security Agreement) (“Term Loan Agent”) is made as of September 17, 2014 (“Effective Date”), in favor of INSIGHT EQUITY A.P. X, LP, a Texas limited partnership (the “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Term Loan Credit and Security Agreement, dated as of October 26, 2012 (as amended from time to time prior to the date hereof, the “Security Agreement”), Grantor granted to the Term Loan Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Intellectual Property (as defined in the Security Agreement), including the trademark registrations and applications referred to in the attached Schedule A (the “Security Interest”).

WHEREAS, notice of the Security Agreement was initially recorded with the United States Patent and Trademark Office (“USPTO”) on November 8, 2012 at Reel 4896, Frame 0155; and

WHEREAS, Term Loan Agent desires to (i) terminate the Security Agreement and (ii) terminate, cancel and release all security interests granted in the Intellectual Property (as defined in the Security Agreement), including but not limited to the Intellectual Property listed on Schedule A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Term Loan Agent hereby covenants and agrees as follows:

1. Term Loan Agent hereby terminates the Security Agreement and hereby absolutely, unconditionally and irrevocably terminates, cancels and releases the Security Interest.

2. Term Loan Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of the Grantor. Term Loan Agent hereby authorizes the Grantor to make any such filing with the United States Patent and Trademark Office as may be reasonably determined by each Grantor to be required to record and evidence the termination, cancellation, and release of the security interests in the Intellectual Property (as defined in the Security Agreement), including the trademark registrations referred to in the attached Schedule A.


